	January 20, 1981-January 20, 1989	Ronald Reagan Became The 40th President of The United States.
	January 20, 1981	George H. Bush Became Vice President of The United States Under Ronald Reagan
	March 29, 1981	John Hinckley's Brother, Scott was Scheduled to Have Dinner with His Close Friend, Neil Bush. He settled in the Denver area where he was friends with members of the family of John Hinckley Jr., who shot President Reagan.
	March 30, 1981	<p>Assassination Attempt on Ronald Reagan</p> <p>Bush's ambition to depart from Reagan's foreign policy and aid in the establishment of a one-world government was the driving force behind the assassination of President Reagan. The Reagan assassination attempt involved two shooters, not one, and there is photographic and eyewitness proof of a second man standing on a balcony with a gun, who is clearly seen in the uncropped photographs.</p> <p>According to the government, there were five bullets, and the trajectory of the round that entered Reagan could not have originated from John Hinckley's crouching position. It's surprising that the government won't make any of the pictures available.</p> <p>Reagan's Vice President, George Bush, and Secretary of State Al Haig disagreed over who should oversee the nation's foreign policy. Poppy favored the "New World Order." Haig had the outmoded view that, as president, he should implement Reagan's foreign policy, even though it was more conservative than what Bush favored.</p> <p>There were two distinct executive orders on Reagan's desk. one appointing Haig as in charge of foreign policy, one giving Bush authority.</p> <p>Following a failed assassination attempt and three days in the hospital, Reagan returned and signed the order appointing George Bush to operate the machinery.</p>
	November 2, 1984	Anthony Fauci Became The 5th Director of The National Institute of Allergy and Infectious Diseases. In a 2020 interview with The Guardian, Fauci remarked, "My career and my identity has really been defined by HIV." He was one of the leading researchers during the AIDS epidemic in the early 1980s. In 1981, he and his team of researchers began looking for a vaccine or treatment for this novel virus, though they would meet a number of obstacles. In October 1988, protesters came to the National Institute of Allergy and Infectious Diseases. Fauci, who had become the institute's director in 1984, bore the brunt of the anger from the LGBTQ+ community who were largely ignored by the

		government. You cannot patent a naturally occurring virus. AIDS has a patent number of 5676977. AZT was the treatment prescribed to treat AIDS and it was the cause of death.
	March 15, 1985	US Embassy Meeting in Tegucigalpa. Meeting with William Barr, Mike Harari, Buddy Young, and Chip Tatum. Mr. Barr was an emissary of Vice President George H. Bush. This meeting was designed to set up future meetings for the Vice President.
	March 24, 1985	Meeting At a Remote Resort in Costa Rica. A meeting was held with William Barr, Barry Seal, General Noriega, and Bill Clinton to discuss the loss of over \$100 million dollars worth of drugs and cash that had been siphoned from the "Enterprise". Either Seal, Clinton, or Noriega was to blame as the loss came from the Arkansas drop.
	November 1986	The Iran-Contra Affair Was a Political Scandal in The United States That Came to Light in November 1986. During the Reagan administration, senior administration officials secretly facilitated the sale of arms to Iran, the subject of an arms embargo. Some U.S. officials also hoped that the arms sales would secure the release of hostages and allow U.S. intelligence agencies to fund the Nicaraguan Contras. Under the Boland Amendment, further funding of the Contras by the government had been prohibited by Congress. Although the term "Iran-Contra" was initially coined to reference the scandal involving the Reagan Administration's illegal selling of weapons to Iran to fund Contra terrorists in Nicaragua, the scandal is a bit more expansive than the name would suggest. It was later discovered that they had another source of funding for the Contras: crack cocaine. The Reagan Administration and the CIA hatched a plan to conspire with the Contras to smuggle cocaine from South America into the United States. They turned a blind eye to cocaine smuggling by the Contras and shielded the drug smugglers from investigations. Reagan's officials in the White House, including Oliver North, began to nurture the cocaine smuggling and funnel the proceeds to the Contra army in Nicaragua. That Jeb Bush was a pot dealer at Andover is beyond dispute, but there is also some evidence that Jeb dabbled in cocaine both as a dealer and user. Legendary CIA drug smuggler and pilot Barry Seal claimed to his Miami lawyer Richard Sharpstein that he had orchestrated an elaborate sting at the Opa-Locka airport in which the DEA got videotape of Jeb and his brother George W. Bush bringing a kilo into Florida for resale. Supposedly Seal, who was deeply involved in the trafficking of cocaine into the United States through rural airstrips in Louisiana, Texas, and Arkansas, threatened to expose the Bushes' role in the drug trafficking unless then-vice President George H. W. Bush got the IRS, who were pursuing Seal over his vast drug profits, off his back. While I have been unable to prove this allegation, I did learn something even more incredible. The FAA ownership records of the turboprop King Air 200, which Seal used in the CIA effort to import drugs into the United States in order to sell them to raise cash to finance the Nicaraguan contras, show that the plane was subsequently purchased by the state of Texas, where it was used by Governor George W. Bush. Because the Barry Seal saga has more to do with George H. W. Bush than Jeb, we will explore it later. ³⁰ Legendary CIA operative Chip Tatum also claimed Jeb Bush was deeply involved with the CIA-led operation to traffic cocaine into the United States and sell it to raise money to fund the Nicaragua Contras after the US Congress cut off funding in the Boland Amendment. Tatum claimed Arkansas governor Bill Clinton was in on the operation which Col. Oliver North ran.
	November 14, 1986	The National Childhood Vaccine Injury Act (NCVIA) Of 1986 (42 U.S.C. §§ 300aa-1 To 300aa-34) Was Signed into Law By United States President Ronald Reagan As Part Of A Larger Health Bill.
	January 17, 1989	Cleveland Elementary School Shooting (Stockton, CA), Five Were Killed And 30 Wounded by A Man with A Semi-Automatic Weapon.
	January 20, 1989	George Herbert Walker Bush Became The 41st President of The United States. Poppy defeats Michael Dukakis winning 79% of the electoral and 53% of the popular vote. At his campaign nominating event, he uttered the words, "Read my lips: no new taxes". In his Inaugural Address, he spoke about, "A Thousand Points of Light". Later, A Thousand Points of Light formed the name of a private, non-profit organization launched by Bush to support volunteerism. "One of the global centers of Satanism is the Castle of Darkness, the Chateau des Amerois or Castle of Kings in Belgium, near the appropriately named village of Muno Bel. The castle is close

		<p>to the French border and some 20 kilometers from Luxemburg. It is protected from view by thick forests and guards keep out the curious. 	March 14, 1989	Temporary Ban on Import of Semi-Automatic Rifles Announced By Bureau Of Alcohol, Tobacco, & Firearms.
	March 24, 1989	<p>The Exxon Valdez Oil Spill.</p> <p>If you go back and look at the coverage, in the days following the first reports that the Exxon supertanker's hull had ruptured on Bligh Reef, spilling more than 10 million gallons of oil into the pristine Prince William Sound, a gusher that ended up covering 11,000 square miles of ocean, you'll see that Bush was mostly a non-player in that unfolding drama, which quickly became the worst environmental disaster in U.S. history. Bush barely even warranted mention during the blanket news coverage.</p>
	June 29, 1989	<p>Male Prostitution, Call Boy Ring Investigation into VP George H. Bush.</p> <p>The alleged leader of what authorities have called the largest male prostitution operation in the Washington area surrendered to federal agents yesterday and pleaded not guilty to racketeering charges that have been filed against him and three alleged accomplices. Henry W. Vinson, 29, of Williamson, W.Va., a coal miner's son accused of setting up the homosexual escort service, was arraigned in U.S. District Court here yesterday afternoon after turning himself in to Secret Service agents . . . At a news conference after the arraignment, [U.S. Attorney Jay] Stephens said the investigation into the alleged prostitution ring "is concluded" and that the indictment, which was unsealed yesterday, focused on those who allegedly set up the ring rather than on clients who reportedly patronized it. Asked about earlier reports that some of those clients included high-level officials in the Reagan and Bush administrations, Stephens said the investigation had not revealed "additional conduct which suggests criminal conduct on behalf of other people." . . . The Vinson case provoked additional notice after The Washington Times published reports last summer suggesting that the alleged prostitution ring had been patronized by government officials. The Times named as clients several low-level government employees and Craig J. Spence, a Washington lobbyist and party-giver who, the paper said, took friends and prostitutes on late-night tours of the White House. Spence was found dead in a Boston hotel room last fall, and authorities ruled his death a suicide . . . To date, however, investigators have disclosed no evidence linking any high-level government official to the escort service.</p>
	July 7, 1989	The Administration Bans the Import Of 43 Types of Semi-Automatic Weapons (But Does Not Affect Domestic Manufacturers.)
	July 7, 1989	<p>The Creation of FIVE STAR TRUST In the Isle of Man in Nevis, West Indies.</p> <p>During the tenure of Richard Helms as Director of the Central Intelligence Agency, decisions were made to draft a blueprint and put in motion a plan by which the CIA could have as much funds as, and when needed, without the knowledge of Congress. This would accomplish the dual purpose of carrying out clandestine and covert operations without the "clearance" of Congress, as well as avoid the necessity of having to request any extra funds, and thus, divulging the workings of any covert operations in progress or planned.</p>
	July 7, 1989	<p>Top Secret, Full FBI Report Released to Senator Edward Kennedy on the "Japanese/Singapore/New Zealand/Kentucky" Connection.</p> <p>It inadvertently revealed the existence of a clandestine group of five individuals called the "Gang of Five" created in 1966 This team of five people: General Edward Landsdale, William Colby, George Bush, Richard Armitage, and Lt. Col. Robert Ferrera, would enter the drug smuggling business in a total and complete fashion in what was called Eagle II. Bush was tasked with handling all the shipping of the drugs under forged waybills and handling all the opium from China.</p> <p>After the puppet of the CIA, Prime Minister of Japan, Kakuei Tanaka was found with his hands in the cookie jar making money on the side in the scandal involving Lockheed Aircraft, Tanaka was forced to resign. This was too close to all being made public so Helms who had strong relationships with the real capital of the world, The Rothschilds, so Helms had Bush terminate Eagle II and wash away any traces.</p>

	June 26, 1990	Bush Reversed The “No New Taxes” Pledge with His Statement on Financial Budget Negotiations.
	July 1990	<p>George H. Bush’s Administration Supplied Saddam Hussein with The Majority of His Military Armaments, Chemical Weapons, And Biological Agents Weeks Prior To Iraq’s Invasion Of Kuwait. Tanox Biological Systems was co-owned by Bush’s Secretary of State James Baker III. TBS made some of the vaccines used to poison our military (Gulf War Syndrome.) Some of the biological agents supplied to Iraq included Anthrax and West Nile Virus.</p> <p>Tanox collaborated with Baylor University College where George H. Bush served in an official capacity concerning Mycoplasma infections and related vaccinations. Tanox was also closely linked to Dr. Shyh-Ching Lo, who, underemployment by The Armed Forces Institute of Pathology, isolated and patented a “Pathogenic Mycoplasma” originally taken from an AIDS patient, that somehow contaminated many of the vaccines given to allied military personnel traveling to the Middle East in lieu of “Operation Desert Storm.” Only the French soldiers who did not receive the American-made vaccines did not develop GWS during this earlier war with Iraq.</p> <p>Bush was a major shareholder in Tanox Biosystems of Houston.</p>
	August 2, 1990	<p>Iraq Invades Kuwait. On 2 August 1990, Iraq invaded neighboring Kuwait and fully occupied the country within two days. Initially, Iraq ran the occupied territory under a puppet government known as the "Republic of Kuwait" before proceeding with an outright annexation in which Kuwaiti sovereign territory was split, with the "Saddam Yat al-Mitla' District" being carved out of the country's northern portion and the "Kuwait Governorate" covering the rest. <u>Varying speculations have been made regarding the true intents behind the Iraqi invasion, most notably including Iraq's inability to repay the debt of more than US\$14 billion that it had borrowed from Kuwait to finance its military efforts during the Iran-Iraq War.</u> Kuwait’s demands for repayment were coupled with its surge in petroleum production levels, which kept revenues down for Iraq and further weakened its economic prospects; Throughout much of the 1980s, Kuwait’s oil production was above its mandatory quota under OPEC, which kept international oil prices down. Iraq interpreted the Kuwaiti refusal to decrease oil production as an act of aggression towards the Iraqi economy, leading up to the hostilities. The invasion of Kuwait was immediately met with international condemnation, including in Resolution 660 by the United Nations Security Council (UNSC), which unanimously imposed economic sanctions against Iraq in Resolution 661. British Prime Minister Margaret Thatcher and American President George H. W. Bush deployed troops and equipment into Saudi Arabia and openly urged other countries to send their own forces to the scene. In response to the joint call, an array of countries joined the American-led coalition, forming the largest military alliance since World War II. The bulk of the coalition’s military power was from the United States, with Saudi Arabia, the United Kingdom, and Egypt as the largest lead-up contributors, in that order; Saudi Arabia and the Kuwaiti government-in-exile paid around US\$32 billion of the US\$60 billion cost to mobilize the coalition against Iraq.</p>
	January 1991	<p>The Gulf War began. The Gulf War was an armed conflict between Iraq and a 42-country coalition led by the United States. The coalition's efforts against Iraq were carried out in two key phases: Operation Desert Shield, which marked the military buildup from August 1990 to January 1991; and Operation Desert Storm, which began with the aerial bombing campaign against Iraq on 17 January 1991 and ended with the American-led Liberation of Kuwait on 28 February 1991.</p>
	April 18, 1991	<p>Neil Bush Savings and Loan Scandal. Neil stole millions from Silverado Savings and Loan. Bush was a member of the board of directors of Denver-based Silverado Savings and Loan from 1985 to 1988 during the S&L crisis of the 1980s. Since his father George H. W. Bush was Vice President of the United States, his role in Silverado's failure was a focal point of publicity.</p> <p>The U.S. Office of Thrift Supervision investigated Silverado's failure and determined that Bush had engaged in numerous "breaches of his fiduciary duties involving multiple conflicts of interest." Although Bush was not indicted on criminal charges, a civil action was brought against him and the other Silverado directors by the Federal Deposit Insurance Corporation; it was eventually settled out of court, with Bush paying \$50,000 as part of the settlement</p>
	June 12, 1992	Poppy Signs the Framework Convention on Climate Change.
	November 19, 1992	George H. Bush’s Mother, Dorothy Walker dies.

December 17, 1992		<p>U.S. President George H. W. Bush, Mexican President Carlos Salinas de Gortari, and Canadian Prime Minister Brian Mulroney signed the North American Free Trade Agreement (NAFTA). GWB's brother Jeb Bush, former governor of the Sunshine State was a buddy of Raul Salinas de Gortari who had ties to Mexico's Drug-lord Juan Garcia Abrego.</p> <p>George H. W. Bush developed close personal ties with Carlos Salinas de Gortari (former president of Mexico) and his dad Raul Salinas Lozano who, according to the Dallas Morning News (February 27, 1997) was "a leading figure in narcotics dealings that also involved his son, Raul Salinas de Gortari... And Raul was an intimo amigo of Jeb Bush, (former Governor of Florida) and the brother of George W., Bush.</p> <p>George H. W. Bush Senior was fully aware when he signed onto NAFTA of the links of the Salinas presidency to the drug lords.</p>
January 20, 1993-January 20, 2001		<p>William Jefferson Clinton became the 42nd President of the United States.</p>
January 17, 1995 – December 21, 2000		<p>George W. Bush Became The 46th Governor of Texas</p>
June 25, 1996		<p>A Terrorist Attack on The Khobar Towers At about 9:30 pm in the evening, a huge explosion rocked the barracks for the United States Air Force 4404 Provisional Wing in Khobar, Saudi Arabia. The blast from a truck bomb was so massive it was felt in Bahrain 20 miles away. Nineteen American airmen were killed and 498 people were wounded, most of them Saudis and foreign guest workers in nearby buildings next to the parking lot where the bomb exploded.</p> <p>The terrorist attack on the Khobar Towers was the bloodiest attack on America between the Beirut Marine barracks disaster in 1983 and September 11, 2001. Its legacy still haunts Washington's relations with Iran. Guess who was awarded the contract to rebuild, the Bin Ladens.</p>
January 5, 1999		<p>John Ellis "Jeb" Bush Is Elected 43rd Governor of Florida Florida governors have more control over how state pensions are managed and how that money is invested than their counterparts in most states. Jeb made use of this influence by using the fund as a political piggy bank and investing the money in financial companies whose CEOs supported his brother's presidential candidacy.</p> <p>Of the total, 250 million dollars went to the Carlyle Group, a private equity firm that Poppy works for. Records show that Lehman Brothers was given control of \$250 million in pension funds for Florida police, teachers, and firefighters in 2005 and 2006. George H. Walker IV, Bush's cousin, managed the alternative investments branch of Goldman Sachs, which received \$150 million. Lehman made nearly \$5 million in fees on Bush's deals alone, making him very profitable for the company. Lehman also secured new contracts to look after an extra \$1.2 billion of Florida's funds.</p> <p>When Bush left office in 2007, Lehman quickly hired him at a rate of \$1.3 million a year. Florida continued to send money to Lehman who used it to buy up increasingly risky products. This included hundreds of millions of dollars of toxic, mortgage-backed securities. The securities defaulted within months, eventually costing the state of Florida more than \$1 billion.</p> <p>Jeb denied having played a role in Lehman's toxic securities.</p>
November 1999		<p>The 1933 Bankruptcy Is Paid Off and All Assets Are to Be Returned to These United States. Supposedly Russell J. Gould discovered a glitch in paperwork back before 1999. Interviewed by telephone at his home in Midland, George W. Bush said, "It's certainly conceivable that I met him or might have been introduced to him" when he was running a losing campaign for Congress in 1978 against Democrat Kent Hance in the 19th Congressional District. Luitbock, the suspect's former home, is in the district.

"I don't recognize his face from the brief, kind of distorted thing they had on TV and the name doesn't ring any bells," George W. Bush said. "I know he wasn't on our staff. I can't expect our volunteer rolls."

He said he had heard, however, of Hinckley's father's oil company, Vanderbilt Energy Corp.

Peter Teeley, the vice president's press secretary in Washington, said he didn't know anything about the Hinckley-Bush connection.

"I don't know a damned thing about it. I was talking to someone earlier tonight, and I couldn't even remember his (Hinckley's) name. All I know is what you're telling me," said Teeley.

Teeley, who accompanied Bush on Monday's flight back to Washington from Texas, said the vice president "made no mention of it whatsoever." If he was familiar with any members of the Hinckley family.

Bush "certainly didn't indicate anything like that," said Teeley.

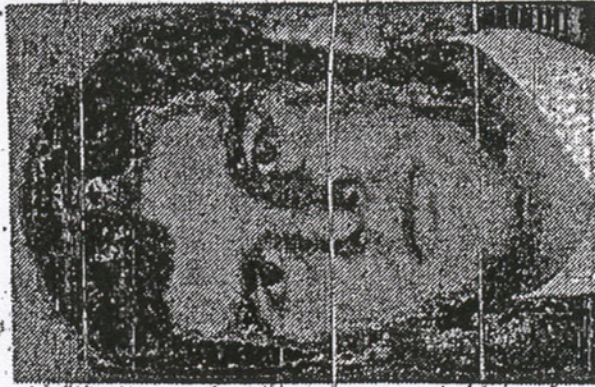
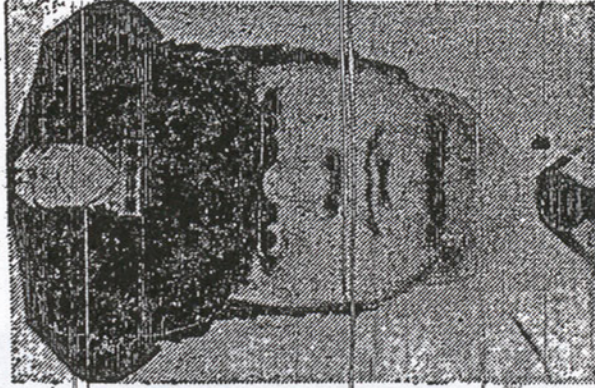
Two other Bush aides who were on the flight, Shirley M. Green and Chase Untermeyer, both said that the vice president gave no indication that he recognized the Hinckley name.

"Frankly, I was with him until we helicoptered back to the Naval Observatory (the vice presidential residence), and I don't believe at that point we even knew the name of who had been wounded in this," said Untermeyer.

Bush Angle to Reagan Shooting Still Unresolved as Hinckley Walks

A Story I Had to Leave Out of My Book

George H.W. Bush knew the family of the man who shot Bush's then-boss Ronald Reagan, in 1981. With the shooter now freed, it's time, finally, to take a closer look.



Why did George H.W. Bush and his cabinet determine that John W. Hinckley Jr. — the man who in 1981 tried to kill the newly inaugurated President Ronald Reagan — was a lone nut, and no conspiracy, foreign or domestic, was involved? How did they arrive at this conclusion just five hours after the shooting, without any thorough examination?

And why won't the Federal Bureau of Investigation release its documents on the shooter?

Hinckley, who was released from a federal psychiatric facility on August 5 after 35 years, remains a mystery, and that's the way the government prefers it. Among the documents the Bureau withholds are those that reveal organizations linked to him — and the names of his associates.

One noteworthy individual will not even acknowledge knowing of Hinckley beforehand, someone associated with the shooter's family, and an even longer history of *dissociation* — George H.W. Bush.

Most Americans have never heard about this — and even those who have will be intrigued by some little-known aspects. One is the rather unique way the Bush clan has dealt with or sought to dismiss such peculiar situations — and this is hardly the only one in which the family has been enmeshed.

Here's an amazing example: Bush Senior, known to family and friends as "Poppy," claimed he **could not remember** where he was when he heard that President John F. Kennedy had been shot. I discovered a good reason why he should have remembered — because he, himself, had been in Dallas that morning.

I learned this while researching the Bush dynasty for what would become the book *Family of Secrets*. I came upon one odd "coincidence" after another, weird ones that would make anyone's eyebrows soar.

I also saw an FBI memo showing that the man who would later become Bush 41 had secretly called the FBI shortly after the shooting of President Kennedy with information on a man he said might be involved. It turned out that not

only was the man *not* involved, but that Bush knew him personally — and even, via a subordinate, gave the man an alibi.

Too weird.

I also learned that Poppy Bush was a longtime acquaintance/friend of George de Mohrenschildt, the mysterious Russian “baron” who was perhaps the closest person to Lee Harvey Oswald in the year before Kennedy’s death.

Imagine my interest when I learned of de Mohrenschildt’s connections to American intelligence — and then that Bush Senior himself had covertly served the CIA for decades before being named CIA director as a purported “outsider” in 1976.

Indeed, he’d been secretly mucking around with the spy agency before, during, and after Kennedy was killed.

The CIA, of course, was later revealed by the Senate’s **Church Committee** investigation to be in the business of arranging the removal — or even the murder — of national leaders in various parts of the world.

Imagine my fascination, then, to learn that John Hinckley Jr., the man who shot and nearly killed President Ronald Reagan in 1981 — an attempt which, if successful, would have resulted in then-Vice President George H.W. Bush moving up to the top spot — was none other than a friend of the Bush family.

How strange is that? So strange that it literally caused *NBC News*’s anchor John Chancellor’s eyebrows to arch as he reported the curious connection.

The story was broken by the now-defunct *Houston Post*, and then picked up briefly by the *AP* and *UPI* wire services, and some newspapers, plus *Newsweek*.

Then it vanished without a trace or further inquiry or comment in the mainstream media.

The story was so baffling and off-putting that even I, in writing *Family of Secrets* more than a quarter-century later, did not mention it. I was preparing to publish a book with so many shocking elements that the publisher and I worried about whether the mainstream media would even dare cover it, or review it fairly; in that context, the Hinckley-Bush connection seemed one provocation too far.

Fast forward to early August of this year, when news came that a federal judge had ordered John Hinckley released from captivity. Hinckley had already been granted partial freedoms over the years, including extended stays with his family outside the mental facility where he has been incarcerated. But now he is effectively “out,” albeit with some supervision.

Word of Hinckley’s release was met with pregnant silence, including from entities and individuals that bray about “law and order” — who routinely support jail time with no possibility of parole for all manner of individuals, particularly the poor and the unconnected.

Neither description, of course, fits Hinckley.

The Hinckleys and the Bushes have been friendly for decades, going back to the days when both families set down stakes in the dusty town of Midland, Texas, a magnet for the children of wealthy, East Coast families seeking to cash in on the oil boom.

The Hinckleys were donors to Poppy Bush's political campaigns over the years, and they gave to support the first, unsuccessful bid for Congress of the young George W. Bush, in 1978. The families lived close to each other, they socialized; I saw indications that, at one point, they may have shared the same lawyer.

Even more strangely, Neil Bush, son of the vice president, was scheduled to have dinner with Hinckley's brother, Scott, the day after the shooting.

The shooting took place on Monday, March 30, 1981. Neil and his wife, Sharon, were to have dinner with a girlfriend of hers who brought along Scott Hinckley as her date. Scott had supposedly been invited to round out the foursome.

Neil and his wife, and Scott, all lived in Denver at the time. Scott's father's oil company, Vanderbilt Oil, had its headquarters in Denver at that time. Scott was a company vice president.

Meanwhile, the shooter, John W. Hinckley Jr., lived from time to time with his family in a small town outside Denver. In fact, at the time he shot Reagan, he was living with his parents.

This put Neil Bush, the senior Hinckleys, Scott Hinckley, and would-be presidential assassin John W. Hinckley Jr. in close quarters over an extended period.

Neil might reasonably have been aware that John Jr. was having serious problems, and was in psychiatric care. And — given the Bush family's politically-driven strategy of tracking and staying in touch with huge numbers of family friends and acquaintances, plus a fondness for sharing the doings of their network among themselves — the probability that Neil would have relayed to his parents John Jr.'s mental problems, and psychiatric treatments, is not remote.

In the fall of 1980, Hinckley was arrested at Nashville airport carrying three guns on the very day that then-president Jimmy Carter arrived in that city. (He is believed to have been stalking Carter, against whom the Reagan-Bush ticket was locked in combat) He was neither fingerprinted nor charged.

Notwithstanding the commonness of guns in Tennessee, once he was in custody, nobody seems to have discovered his troubled background and psychiatric problems or expressed any concern that a gun-toting non-local was arriving in the same city at the same time as the president.

(It's interesting to note that just as Hinckley stalked candidates of both parties with widely differing political philosophies, authorities claimed that Lee Harvey Oswald took shots not only at President Kennedy, but also at General Edwin Walker, a Kennedy nemesis on the hard right.)

In late 1980 and early 1981, Hinckley was also stalking the actress Jodie Foster. He said that he had been hearing “voices” in his head — and became convinced that he and Foster had a special bond.

Interestingly, notes by Hinckley describing a conspiracy to assassinate a president were found in a search of his prison cell, according to *Breaking Points*, a memoir written by his parents. They said the notes referred only to “an imaginary conspiracy” and his lawyers dismissed them as far-fetched. They have never surfaced publicly.

The FBI declined to release 22 pages of documents that included the names of associates and organizations linked to Hinckley, and details of his finances..

A jury bought the story that the Hinckley case was strictly one of a deranged individual obsessed with an actress and he was found guilty and packed off to the Washington-area St. Elizabeth’s mental hospital — an institution with a fascinating history of involvement with the CIA’s MK-ULTRA program, which focused on mind control experiments — and efforts to study the possibility of “programming” killers. Psychiatrists played a crucial role in recruiting subjects for these experiments. (Documents on Hinckley’s psychiatric records are among those kept secret.)

Congressional hearings in the 1970s revealed the existence of MK-ULTRA and these mind-control programs. Five years before the Reagan shooting, at the time of those hearings, the new CIA director was.... Poppy Bush.

John Hinckley Sr. (“Jack” Hinckley) was deeply involved with World Vision, a nonprofit humanitarian organization that receives heavy funding from USAID, the government organ that has historically been closely associated with the Central Intelligence Agency. He was close with the head of World Vision’s ministries, a former State Department official who worked, among other things, as an adviser in Vietnam.

Interestingly, another “lone nut” who changed the global landscape, Mark David Chapman, who shot and killed John Lennon, had been an employee of World Vision.

Vice President Bush seems never to have personally commented on his connections with the Hinckleys. In a typical non-response — which I noted in *Family of Secrets* is a Bush family tactic in dealing with sensitive information — a Bush aide, press secretary Peter Teeley, told a UPI reporter the day after the arrest: “I don’t know a damn thing about it. All I know is what you’re telling me.”

Of course, the issue was not what the British-born Teeley knew, it was what his boss knew. Asked whether Bush had mentioned knowing the Hinckleys, Teeley replied that the veep “made no mention of it whatsoever.” So there we have it: no actual comment from Poppy Bush himself.

Neil Bush, at a press conference the day after the shooting, did admit to one connection with the Hinckleys: he mentioned, in passing, that Scott Hinckley had also been at his house a couple of months earlier, at his surprise birthday party. Ostensibly he was there as the “date” of the same “close” female friend who was scheduled to dine with the Bushes the day after the shooting.

The apparent use of the woman friend of Sharon Bush to explain any connection between the families, despite an already existing direct connection between the families, warranted more attention.

This was again a typical pattern I had noted with the Bushes: stress another person, in this case, the female friend, as if she were the only connection between the Bushes and the Hinckleys, thereby diverting attention from the central fact: the Bushes and Hinckleys were themselves longtime friends. (Neil did claim he had never met the gunman or the gunman's father — a claim that would be hard to disprove — and that would in any case hardly matter given the family-to-family connections.)

In any event, no evidence has ever surfaced that any of the Bushes were so much as questioned about their relationship to the Hinckleys by the FBI, Secret Service, or any other entity, and no investigation, informal or formal, appears to have taken place.

Meanwhile, the media's focus was on the highly unpopular Secretary of State, Alexander Haig, whose statement that "I'm in charge here" in the minutes after Reagan's shooting was turned into a meme that is remembered to this day, despite the fact that Haig had merely stated that he was in charge as the third in succession, "pending the return of the vice president and in close touch with him."

Thus, the Haig story became a sensation, and successfully distracted just about everyone from the weird Bush-Hinckley connection.



Poppy would have become president if Reagan died, rather than waiting eight long years. He had engaged in a bitter primary campaign against Reagan, who then surprised many people by taking Bush as his running mate. (Richard Nixon, once asked by an aide why he took such an unappealing and unpopular figure as Spiro Agnew as his vice president, reportedly answered, "assassination insurance." It's interesting to note that George H.W. Bush similarly chose Dan Quayle, a figure widely considered a "lightweight" ill suited to the presidency, as his running mate.)

In any case, although Reagan survived, Bush for a time served as *de facto* president — and after Reagan's resumption of "power," Bush remained an astonishingly influential vice president, to many, the real power in the country in many respects ever after.

Around the time of the shooting of Kennedy in Dallas, the Hinckleys were operating out of Dallas, with offices in the Republic Bank Building, a tower which housed many entities and individuals connected by varying degrees to intelligence activity, including the offices of the mysterious Russian “baron” George de Mohrenschildt (an old friend of George H.W. Bush), who was perhaps the principal influence in the life of Lee Harvey Oswald in the year leading up to the shooting of Kennedy.

In 1978, not long before Poppy Bush’s presidential bid, his son George W. was making his first bid for elective office (with donations from the Hinckley clan). Neil Bush was W’s campaign manager, living in the city of Lubbock.

Another person living there at that time was... John Hinckley Jr. Asked about that by a newspaper reporter, W. commented that it was “conceivable” Neil would have met Hinckley during that period.

As for himself, W. said at the time, “It’s certainly conceivable that I met him or might have been introduced to him. I don’t recognize his face from the brief, kind of distorted thing they had on TV and the name doesn’t ring any bells. I know he wasn’t on our staff. I could check our volunteer rolls.”

Was there any follow-up? Did Bush ever seek to learn more about Hinckley or explain what ways they were or were not acquainted? Not that I can find.

And then there is this: The very day that Reagan was shot, the Reagan-Bush Department of Energy notified the Hinckley family at Vanderbilt oil that the government might be forced to penalize the family business to the tune of \$2 million. (AP, April 1, 1981) Was Scott coming to dinner with Neil to try to sort it out? Whatever happened, after John Hinckley shot Reagan, the penalty never materialized.

Neil never did provide a more satisfying explanation of why the shooter’s brother was coming to his house for dinner than that he was filling in as a date for a friend of his wife’s. But who had suggested the dinner in the first place, and who had recommended Scott be one of the foursome? That remains murky.

As for the shooter, here’s what Neil said about whether he knew or had met him: “I have no idea,” he said. “I don’t recognize any pictures of him. I just wish I could see a better picture of him.”

In a memoir, Bush aide Chase Untermeyer, who accompanied Bush to the unveiling, writes:

I washed up and went to bed for a nap before writing this entry. Around 1:30, I was awakened by a call from Art Wiese of the Houston Post. Art related the possibility that Neil Bush (the VP’s son) may be acquainted with the alleged assailant, John W. Hinckley Jr. Neil and Sharon do know Hinckley’s brother (in Denver) and were planning to have dinner with them tomorrow night. The Hinckleys are a prosperous family, and John Sr. may have been a Bush contributor. Art wanted to know if this connection was known by GB...

As Art pointed out, even a slight Bush connection in this shooting could set off the conspiracy freaks.”....

“What’s up?” GB asked, seeing us all there.

“Did you talk to Neil last night?” Pete asked as we entered the West Basement.

“No; is it about this guy?”

“Yes.”

“Jesus.”

We all went into the VP’s office, where Pete related the story that Wiese had been working on and which was being played big in Houston and over the wires. GB appeared only mildly concerned, so little in fact that he didn’t think to call Barbara or ask any of us to do so.

This should have been one of the most investigated, most heavily reported stories for years after. Certainly, in contrast to the email scandal, Benghazi, Travelgate, and other complex and somewhat esoteric matters that became media rages, lasting on and on and dominating the public conversation, this peculiar Hinckley matter — which by any measure passes all the tests for something worthy of interest by law enforcement — just vanished.

Even when Neil Bush’s involvement in the massive Savings and Loan collapses that dominated headlines in the 1980s was widely reported, no mention was made of the fascinating Bush-Hinckley connection.

To sum up: John W. Hinckley’s brother attends a surprise birthday party at Neil Bush’s house in a period when John Hinckley was suffering serious mental problems. The government exerts financial pressure on the Hinckley family business. Hinckley shoots President Reagan, nearly making Neil Bush’s father the president. The financial pressure on the Hinckleys disappears, George H.W. Bush is in charge of the “investigation” of the shooting, the Hinckleys chalk it all up to their son’s demons, everyone focuses on Jodie Foster, and that’s the end of that.

Coincidence? Sure. Anything, after all, is possible.

AIDS caused by contaminated Hepatitis B vaccine: Dr Judy Mikovits

Dr Judy Mikovits, top-level molecular virologist and author of 'Plague of Corruption: Restoring Faith in the Promise of Science' joins Lucas Alexander on the Age of Truth YouTube channel. Mikovits worked at the National Institutes of Health under Anthony Fauci for decades, who she says stole her proprietary research not once, but twice.

Since the very beginning of the COVID-19 psyop, Mikovits has been speaking out against the official narrative that has triggered the global lockdowns and economic collapse, calling it a "plandemic", orchestrated by agents of Big Pharma.

She first crossed paths with Anthony Fauci in 1980, when she worked at NIH at the National Cancer Institute, where she collaborated with Dr Frank Ruscetti and helped him replicate the work of French virologist, Luc Montagnier to isolate the HIV virus. Fauci, who was her boss delayed publication of their paper for 6 months to let his protégé, Robert Gallo replicate, publish and take credit for their work.

She says the delay allowed AIDS to spread around the globe, which in turn helped Fauci get promoted in 1984 to Director of the National Institute of Allergy and Infectious Diseases, where he remains to this day.

In 2006, Dr Mikovits became director of Whittemore Peterson Institute for Neuro-Immune Disease, collaborating again with Dr Ruscetti to search for the cause of Chronic Fatigue Syndrome (CFS). She discovered that 67% of women with CFS carried a virus—called Xenotropic Murine Leukemia-Related Virus (XMRV), which only appeared in 4% of healthy women.

XMRV is associated with prostate, breast, ovarian cancers, leukemia, and multiple myeloma. Many women with XMRV have given birth to children with autism. Mikovits and Ruscetti published their findings in 2009.

In 2011, their research strongly indicated that the highly-infectious XMRV virus was present in the MMR and Polio vaccines given to American children and in the Japanese Encephalitis vaccines given to US military personnel.

Mikovits says, "We recognized that this mouse retrovirus was causing an alarming national health crisis. That is, the blood supply and the vaccines were heavily-contaminated with mouse viruses of many strains."

US doctor directing Covid response, Anthony Fauci is a total fraud

Before she could warn the public, Fauci used his power to silence her. When she refused, Dr Fauci stepped in and ordered all her computers and notebooks confiscated and he orchestrated the retraction of their science paper. He then removed all of Mikovits' funding and prevented her from getting a job in government research from 2012 forward.

She believes that the AIDS epidemic that spread throughout the world was caused by the Hepatitis B vaccine, which was contaminated, "But this information was kept from people, as they spread the disease. They prevented therapies, like Peptide T therapy, which our colleague, the late Candace Pert and Dr Ruscetti had actually designed. It's a modulated peptide [whereas, Fauci advocated] high levels of toxic AZT...

When Mikovits started her PhD thesis in 1987, it was only known that the molecule called the Helper CD4 T cell was the receptor where the HIV virus entered the cells. Later, it was discovered that Peptide T was blocking the interaction with a different chemokine receptor called CCR5.

She says, "Peptide T blocked the interaction from the monocyte to the T cell and was therapeutic – but they owned the patents on T cell therapy, so the therapies at the time were all targeted towards the T cell...and it was clear they weren't working. Yet, the FDA prevented Peptide T from ever getting approval."

Then, as now, she says, “Doctors were asking questions, not unlike today with COVID-19. We are asking questions and our questions are being censored – or our publications, as you’ve seen from what’s happened to me...

“We know now, 30 years later that the vaccines have driven essentially every pandemic and that’s why we’re calling them ‘plandemics’. Just like Zika in 2017, the Ebola outbreak in 2014, clearly was a lab-manipulated virus. I’m not going to say ‘engineered’, I’m going to say ‘manipulated’, because we grew it and that was one of my jobs...and I’m saying the exact same thing right now.

“So this coronavirus was grown in viral monkey kidney cells and spread around the world and the flu vaccines are contaminated with other viruses, other coronaviruses, other retroviruses, bird retroviruses...

“Our work in 2011 should have changed the world and COVID-19 is really a cover-up of those 50 million people, worldwide who they’ve infected now with gamma retroviruses, with contagious, cancer-causing viruses and this is why everything’s called COVID-19, no matter why you die.

“The virus SARS-CoV-2 satisfies zero of Koch’s postulates, meaning everybody with the infection gets the disease. It hasn’t been isolated and shown to be infectious and transmissible, the way we did in our 2009 paper. You take it out of one sick person, isolate it, purify it and then inject it or expose it to another sick person or an animal and get the same disease. That kind of work was done with HIV, was done with the XMRVS but hasn’t been done with SARS-CoV-2...

“I think there’s more than one virus there and I’m sure there are a few viruses there but the work to show the disease association hasn’t been done.”

As for the tests, she says the Polymerase Chain Reaction (PCR) tests, “contain the RNA, but that’s not the virus that’s just the blueprint of the virus that’s just the RNA...so we don’t know that it’s actually SARS-CoV-2, versus another coronavirus closely related in crosstalk.”

So, when people test positive for SARS-CoV-2, she says it’s not really known what they’re testing positive for, because, “We’re not allowed to see the tests, we’re not allowed to see what they’re testing. We know they’re 80% false positives. All you’ve got is a piece of an RNA from a coronavirus. That’s all you know, is that a piece of that that’s not infectious and transmissible...

“I would say that COVID-19 the disease, is as I said, a ‘pandemic’, intended to take away our rights to – One World Order – to force us into a fear situation...The virus, SARS-CoV-2 exists. It’s not fake, it’s there but it has little to do with the disease, if anything to do with the disease, COVID-19...

“It’s pretty clear now, all the way back to Smallpox, outbreaks on the Spanish Flu of 1918, the Zika...the flu in 1957 and ’58, which was bad in this country was absolutely spread by a vaccination program, whether it be DTP, which is the vaccination program in Brazil, which spread Zika, where we activate expression of viruses that normally do nothing in animals; we jump them into humans with the spraying programs.

“So everything you see around our world that you’re saying; the 5G, the glyphosate, the spraying of Roundup and everything that they’re driving, these pandemics and yes, it’s deliberate because...everything they told us to do is harming our immune system and causing and driving the disease and any potential viruses around the globe.”

When asked if any vaccine was ever any good, she answers, “In my experience, since 1986 never has a safety study or an efficacy study been done on a vaccine. So, the answer is, I can’t say ‘yes’, because there’s no data. There’s no evidence to show these vaccines ever did anything and in fact, there’s much evidence to the contrary, as we look back and we look at these things.”

General Noriega and Mr. Barr greeted the aircraft when we arrived. The passengers adjourned to their meeting while I secured the aircraft. I was invited to join when I finished. Two Latin American soldiers set up the Sat/Com device and stood guard on the aircraft. I joined the meeting approximately thirty minutes later.

When I arrived, the discussion was concerning the **loss of over \$100 million dollars worth of drugs and cash**. The “**Enterprise**” was being drained. There were three Compaq Computers set up with operators, obviously working for Mr. Barr. There were approximately eight (8) administrative personnel correlating data provided by computer discs brought by the principles of the meeting. The discussions continued. It was obvious that the purpose of the meeting was to identify the source of the loss.

The money flow was **traced from Panama** to several destinations in the U.S. Their Ohio source was ruled out early. Their Colorado source was also ruled out. That left Arkansas. It was **discussed by the members** that either Seal *or* **CLINTON were siphoning** from the “Enterprise.”

At this point, my food was brought, so I moved to a separate table and ate. By the time I finished, Mr. Fernandez signaled me to join him. We went back to the aircraft and used the phone. He called Mr. North and told him that the loss **was definitely occurring on the Arkansas drop**. He said, “**That means either Seal, Clinton or Noriega.**” (I thought it noteworthy that Mr. Fernandez added General Noriega to the suspect list.) He hung up. I started back, but Fernandez stopped me and told me to get Barr and Rodriguez.

I summoned Barr and Rodriguez to the aircraft. About 15 minutes later, the phone activated and

Barr answered. He listened, not speaking but nodding his head in agreement. When he spoke, he told the caller that it had been determined that the problem existed on the **Arkansas connection**. "I would propose that no one source would be bold enough to siphon out that much money, but it is more plausible that each are siphoning a portion causing a drastic loss." He then acknowledged something with a "Yes, sir," and told the caller he would see him and give an updated report in two days. At that point, the phone was handed to me. I answered, "Tatum." **Vice President Bush** asked me to ensure that General Noriega and Mr. Harari boarded Seal's plane and departed prior to my departure. He also wanted the tail number of Seal's plane. I was told to tell no one that we spoke.

He then instructed me to pass the tail number to North via land lines when I returned to base. I acknowledged and handed the phone back to Barr. Barr stated that he and Fernandez were staying in Costa Rica until the following day. They needed to visit the "ranch." He then terminated the call.

Mr. Barr then made another call. He asked for **Governor Clinton**. He must have had a direct number because he didn't have to wait. He began immediately. He explained that a substantial amount of "**Enterprise**" monies had disappeared. He further explained to Governor Clinton that it was suspected to be in **excess of \$100 million dollars** and that it was definitely disappearing along the **Panama to Arkansas connection**. He **suggested that Governor Clinton investigate** on that end, and that he and Mr. North would continue investigating on the Panama side and that it must be resolved or it could lead to problems. "***Big problems,***" he reiterated. He then asked Clinton to put his best man on it and stated that this was priority one.

Then he terminated the call.

We broke down the equipment. I dropped Noriega and Harari at the airport and waited for Seal to leave in a Lear jet tail number N13SN.

Then I returned the other passengers to Tegucigalpa, the capital of Honduras.

Dear Senator:

Per your oral request of 5 June, 1989, requesting a full report on the "Japanese/Singapore/New Zealand/Kentucky" connection, what follows is as complete and thorough investigation of any and all available files of the Bureau, as well as any TOP SECRET, Confidential, or personal files from the Department of Defense, The Central Intelligence Agency, The Departments of the Navy, Army, and Marine Corps, as well as "borrowed" micro-film records of the World War II Office of Strategic Services (OSS). If this TOP SECRET report were to be "leaked" in any portion, Senator, you understand that our agents, planted in the above agencies, would be exposed, and over 15 years work would be in total disarray. Due to the nature of the one common link in the total operation, which will be outlined, we have interpreted your request to include as full an in-depth investigation into the present assignment of Major General Robert L. Ferrera, as well as into his total work from 2 February, 1942, to present. That investigation is as complete as possible, given the total silence we have encountered whenever we have as much as mentioned his name.

During the tenure of Richard Helms as Director of the Central Intelligence Agency, decisions were made by the director, with implied approval of the Oval Office, to draft a blue-print and put into motion a plan by which the CIA could have as much funds as, and when, needed, without knowledge of Congress. This would accomplish the dual purpose of carrying out clandestine and covert operations without the "clearance" of the Congress, as well as avoid the necessity of having to request any extra funds, and thus, divulging the workings of any covert operations in progress or planned. Director Helms wrote a memo to the Oval Office (we intercepted) in which he stated, in part, ".....If Congress, or any other uninformed "do-gooders" ever become aware of this operation, this agency and its director will invoke the 1949 Central Intelligence Agency Act, which

exempts the CIA from all laws requiring the disclosure of....."functions", names, official titles, salaries, and numbers of personnel employed by the agency....." Using this as the cloak of legality, Director Helms put together a team of five top people.

The five experts picked were, General Edward Lansdale, who ran the CIA activities in Vietnam; William Colby, who was to be put in total command of the blue-print operation when enacted; George Bush, who asked and received approval to have his top aid, Richard Armitage be brought aboard, and Lt.Col. Robert Ferrera, a top CIA asset, who at the time was on an assignment in the Congo on the Patrice Lumumba situation.

Having secured the "implied" go-ahead, the five experts were called in and the task put forth to them. They were given a space of three days to solve the problem and come up with a viable solution. The five met in Washington D.C., and from there travelled to Langley Va.

Four of the five were hand-picked for their very special abilities and expertise: the fifth member of the group, Armitage, was brought along by George Bush as his personal "gopher". Bush was chosen for his knowledge of China and his war-time flying ability, as well as being "on the way up" within the CIA. General Lansdale was brought in because of his expertise as a top CIA asset, especially in breaking insurgencies, as he did with the Huks in the Philippines in the late fifties. William Colby was picked for his knowledge of South East Asia, and to command the operations first phase. Lt.Col. Ferrera was included because of his varied experience as a pilot, as well as his command of over a dozen languages and his position as founder of the Special Forces (Green Berets) and still, at that time, regarded as their unofficial commander in Vietnam. The five names were submitted to the "Godfather" of the CIA, John Foster Dulles, who gave the plan his total blessing.

The group met the deadline and came up with a plan that would be so

and large in scope, that if carried out to the most minute detail, wt would become simple by its mere complexity. The plan presented called for a second airline to be set up by the CIA (the first was "Flying Tigers"). This was done, and the airline was named "Overseas National Airline". This airline, suddenly, without yet having any aircraft, received the contracts for all civilian carrier and military cargo into the Pacific Rim and Southeast Asia. The master plan called for the CIA to enter into the drug smuggling business, in a total and complete fashion. Each of the five planners would have his own field to handle. Bush would be the secret head of ONA and handle all the shipping of the drugs under forged waybills. Armitage would be the "gopher" for the group and the intermediary with any "undesirables". General Landsdale would handle all the distribution network and collection services within the military in Vietnam. William Colby was to handle the setting up of all the man-power---from runners, peddlers, pushers, collectors, and so forth, as well as the elimination of any who might prove to be uncontrollable, be they American or Vietnamese. Lt.Col. Ferrera was to use his contacts in Latin America and in the middle-east, to obtain from various governments the needed drugs-- heroin, cocaine, marihuana, LSD, etc. etc, as ordered by Colby. Bush was to handle the opium from China. The operation was given the name of "Eagle II", at the request of Ferrera, for he felt it would be lucky to have the same code as the "Eagle" project he had participated in when he was with the OSS.

Before the operation was really off the ground, Colby started his phase of elimination of dissidents, and he did so under the code name of "Phoenix Program". Colby became insane with his power and before he was finished with "Phoenix", over 20,000 "suspects" were executed and over 2,500 U.S. citizens were accused by Colby of being "collaborators", and they vanished. Helms attempted over and over again to have Colby eliminated, but found that it could not be done for copies of all plans, as well as secret recordings of all spoken at all of the meetins, were in safe-keeping some place as an insurance policy for Colby against Helms and Dulles. The fault for this fell on Armitage, for he was in charge of security for the meetings, etc. Helms found that he had to make an arrangement with Colby, calling for Colby to resign from the group and forever retain his "secrets". In exchange for the resignation by Colby, Helms, with the approval

of Dulles, promised Colby that he would, in the future, become the Director of the CIA. This promise was kept by Helms. Colby withdrew.

More problems were to be encountered in later years with George Bush and with his aid Richard Armitage. Bush, for his cooperation and silence was groomed for his present position, as well as becoming Director of the CIA. He was named CIA Director so as to increase the operation ten-fold. The only persons who did their job and asked for nothing in return were the two military CIA officers, General Landsdal and LtCol. Ferrera.

The plan was in full force when the United States government encountered continued opposition to its requests from the Japanese government ruling party. To put CIA controlled people in power, Bush personally picked an obscure party, formed in 1955, bankrupt and with very little membership, to back in the possible takeover of government. But the Liberal Democratic Party needed vast amount of funds to carry out their part. They had to "buy" the membership and the votes. It was decided to give to this obscure party all of the funds needed, and before they finally achieved power, a sum over 300 billion Japanese Yen had been funneled to them. This was carried out by LtCol. Ferrera, for he had a very special relationship with the first cousin of Emperor Hirohito, Prince Hiruko Watanabe, and thus the Colonel had an "open-door" to Japanese politicians and to the Diet.

That, in effect, Senator, is the start of the operation "Eagle II", which over time has now evolved into what you refer to as the "Japanese/Singapore/New Zealand/Kentucky" connection.

This connection came about in a rather strange manner, and were it not for unforeseen circumstances, there would not now be any such connection. There is a code name used in this regard, Senator, and that is "Studebaker". They have from time to time changed the code, but it is still spoken of as "Studebaker" by those in charge. As this report proceeds, Senator, you will see where all of the players fit into the puzzle:-----except in reference to anything pertaining

to LtCol. Ferrera (Now MajGen.). It is impossible to even get the agency or the Pentagon, or the Army, the Navy, the Marine Corps, or the Department of Defense to so much as admit to any such person possibly existing. We might add at this time that it is our supposition and strong suspicion the General Ferrera is now the top world-wide CIA "Free" Agent, in charge of all clandestine operations and if needed, assassinations. We have it on totally reliable authority that Ferrera is responsible only to the real director (and secret) of the CIA, Mr. Helms. We have taped conversations between Ferrera and the powerful Baron Phillippe duDaphne, as well as with Helms. It is impossible for us to divulge our methods in the securing of these conversations, Senator. General Ferrera is so deeply buried in secrecy that even those within the upper levels at the CIA confess to ever hearing of him. With our knowledge of the dozens of aliases used by the General, and with our total access to the computer information at the Agency, we have not been able to crack the one code word that would give us the knowledge we seek. Our most trusted agents within all agencies cannot unearth an iota of information on the General's true job, purpose, etc, or his present mission. All we have been able to gather of his present work is that he is "giving a helping hand to a wonderful maligned individual, one Marion Horn". This is an excerpt taken from a "top Secret" report by General Ferrera to then President RR. This report was given by Ferrera to the President in explaining why he (Ferrera) was turning down another star. If he accepted, he would receive another assignment, and Ferrera did not want to desert Horn. This relationship, that we feel is like that of a "father-son", has cost the General dearly, for the General is now on the very brink of total ruin financially. His military pay and his agency pay have been stopped as a result of Ferrera withdrawing from any and all assignments with both the military and the agency, until "My friend, J.R. collects all that is due him".

The amount in question, that now has been arranged to be given to Horn, totals 318 Billion J.Y., all from the sale of drugs to our service personnel. The profits, and the pay-offs have reached such proportions that Mr. Helms has ordered that all operations be terminated.

Since the inception of "Eagle II" in 1966 to 1976, the original "Gang of Five" has gone in different directions. When, in 1973, Helms decided that he could better control international operations from outside the CIA instead as the actual Director, James R. Schlesinger was named for a brief period as Director, and then William Colby started to make loud noises about the promise that had been made to him, and as promised by Helms, Colby assumed the post of Director of the Cia, with Schlesinger being given another assignment. This was done in order to avoid any movement that would endanger the operation of "Eagle II". Colby remained until 1976. In 1976, the hand-picked new Director of the agency was George Bush, who served until 1977 only. This was not a very peaceful time for the agency, for during the seventies, the "puppet" of Helms, Prime Minister Kakuei Tanaka, was found with his hands in the cookie jar, making money on the side in the scandal involving Lockheed Aircraft Co. This was too close to all being made public, so Helms who in the meantime had formed a totally strong relationship with Baron Phillipe duDaphne, who represented the real capital of the world, the Rothschild empire, decided to stop operation "Eagle II", and start another clandestine money-making operation, and leave Japan. (Baron duDaphne, by the way of information, later took over complete control of the International Organisation, the "Organisation De Cooperation Et De Developpement Conomiques" (The Organization for Economic Cooperation and Development), headquartered on Rue Chardon-Lagache in Paris, France. This gave Helms and duDaphne complete control over any "development" operation in the world, and thus a carte-blanch for covert/clandestine CIA operations. With Prime Minister Tanaka being forced to resign, the decision was reached to name George Bush to terminat "Eagle II" and to wash away any traces. For this, he was named Director of the CIA, so that he would have a clear way of doing away with any evidence. This, by the way has been done. This was accomplished, to a certain degree, prior to Governor Carter assuming the Presidency.

Part of the closing solution called for the return of the 318 Billion J.Y. to the CIA, or to whomsoever then Director Bush named as recepient. It was decided that a wealthy and loyal party member was to be found in Japan, one who would agree

to have his name entered into back-dated records as having been the individual who "loaned" the funds to the party. The only logical person was hand-picked by Prince Watanabe, Mr. Soichi Iizuka. Iizuka was a very respected multi-billionaire in Japan and totally loyal to the Royal family, thus he agreed. Now it was necessary to "wash" the funds, for they had to pass thru the Iizuka hands and back to whoever Director Bush designated. To do this, Iizuka suddenly found himself in the possession of Gold Certificates from the Japanese Treasury. With these, Iizuka was instructed to buy a Certificate of Time Deposit (No. 4051100-92), issued by the Mitsui Bank Ltd., Home Office, in Tokyo, Japan. The plan was for Iizuka to "sell" this certificate, and supposedly invest the monies in various countries, with the eventual "story" that all investments had proven to be losers. This was to allow the actual cash to be given to Bush's nominee.

The records that we have photograph copies of, from the top secret CIA files, show that Helms insisted on everything being done to perfection, without any possibility of a slip-up. Then went so far as to legitimize the Gold Certificates by having them registered with the proper international banking institutions, including the World Bank. The penchant for perfection caused that Iizuka work from 1977 until 1983, before the ideal "buyer" was found.

In the meantime, the Gang of Five had dispersed...Colby did become Director of the CIA, as did Bush shortly there-after. Richard Armitage remained as the top personal aid to Bush, and has so followed him everywhere. General Landsdale retired after he suffered a "mysterious" and total memory loss. LtCol. Ferrera resigned from the operation when he discovered that the drugs were being given to U.S. servicemen, and not to the North Vietnamese or the Viet-Cong, as he had been led to believe. A contract by Dulles was put out on the Colonel, but a "leak" enabled the Colonel to defend himself. First the Colonel called upon his dear friend, Prince Watanabe, and informed him of what was transpiring. Then without any stop, the Colonel contacted other very close friends, such as the Baron Luis deMonchey, the Chief Justice of the World Court of Justice, as well as Baron Phillippe duDaphne, whom the Colonel had saved from the Nazi during the 01

mission for the OSS in WWII. As his last trump card, the Colonel called upon Baron Guy Rothschild, the head of the Rothschild banking family. The Colonel had been very instrumental in obtaining fake Nazi credentials for the Rothschilds, which enabled them to escape occupied France in 1943.....They owed him, and he collected. Helms also talked to Dulles to lift the contract, because of the pressure exerted by the cards Ferrera called into play, for as fate would have it, all, save Baron deMonchey, were in some form connected with the whole affair. Ferrera had, and still has, the reputation of being totally ruthless and without mercy when he feels that he has been betrayed, or when he feels one of his very few friends have been betrayed, but all that have ever known him state that the "word of Ferrera is without price". Helms obtained the word from Ferrera that with his oath, he would never divulge any part of the operation. Ferrera agreed, and went so far as to give them the solution to continued control over the Japanese government. The Colonel suggested that the CIA form a new company that would do all of its business in Japan, and have so much success that they would have money to "burn". This money would be used to give to individual politicians....not to the party. It was pointed out by the Colonel that by control of the individual, you control the party. Thus the birth of "Recruit".....and the control, to this day, of the individual and the party in Japan by the CIA.

All of this took a period of years, and it was not until after the Carter administration that any phase of the operation could be moved. When William Casey replaced Adm. Turner as Director of the CIA, the operation started again, and in 1983, November, the "perfect buyer" appeared. We want to point out here, Senator, that recent information has come to light that Armitage continued the operation by changing home bases, with the knowledge of Bush, but with the hands of Bush tied because of the information secreted by Armitage. We feel that certain steps are being taken to "eliminate" by "natural causes" Armitage, and his secret partner, Sununu, of whom I have given to you the proof of his bi-sexuality.

The word was put out into the world financial circles that there was available, at a great discount, a certificate of deposit, in Yen, issued by the Mitsui Bank, Ltd. This brought hundreds of inquiries and offers to the dozen or

so "agents" that had knowledge of this very mysterious C.D. One of these second and third rung agents was somehow put in communication with a Mr. Marion Horn, Jr., a.k.a., J.R. Horn, from Kentucky, and thus began to unfold the Kentucky connection.

Mr. Horn was the first perfect "buyer" to be found, for the buyer wanted by Helms and duDaphne had to be one that had a past record of mixing in financial transactions in the "gray" zone. Never anything illegal, but yet, on the borderline. Mr. Horn, known as "J.R.", was perfect because he was the consummate entrepreneur, developing projects without having the financial backing. It would not do to have anyone well known within the international financial circles, for the press would delve into it fully. Mr. Horn and "Eagle II" seemed to be made for each other, and they met at the perfect time in history. The death of Eagle II and the birth of a buyer came about.

Mr. Horn proved to be exactly what all concerned needed. He managed to do the right things at the right time, including the validation of the original copy of the CD by the Consular Office at the U.S. Embassy in Japan, one Frances Lide. (She disappeared for a while, but within the last year the General located her in Canada). The audacity of Horn is brought out here by the wording by the Consular Official, Lide....."This is to confirm and certify that the above mentioned cash deposit certificate is issued by the Mitsui Bank, Limited., Head Office Japan.".....All of this statement was basically correct. But, what was showned as an "original copy" of the CD was just that a copy of a CD. Also present were two minor assistant managers with Mitsui....Elji Usuyama and Akira Mishima, and by Takashi Takahashi, of the hundreds of attorneys of Mitsui. All three were given the "go-ahead" by Mitsui to do what they did, and in exchange, if anything happened to any of them, their families were to be compensated with One Million U.S. dollars by the Japanese government. All three have met their deaths in an identical fashion at the exact same spot and time. Their families have recived the funds.

It was during this phase of the operation that Helms realized he needed funds for the aid of the "Contras" in Nicaragua. The only solution was to continue



This Certificate of Deposit, Number 4051100-92, was issued by the Mitsui Bank Limited, at our Head Office, here in Nihon, as ordered by the Government of Nihon, and treated with the most delicate of matters.

On instructions of Government, this bank issued the Cash Deposit Certificate in question for the amount of ¥318,000,000,000.00 (Three Hundred & Eighteen Billion Yen), bearing an annual simple interest rate of 5% (Five Percent) per annum. The date of this issuance was the 1st of August, 1977.

There has been much investigation of this matter, and as per instructions of the Government, and the General, you must understand our reluctance to much discussion in this matter, and to the official reply to your request. Upon our having cleared your request with the General, we are permitted to inform you of the status, as of this writing:

The Government of Nihon, as well as the Government of Singapore have arrived at the mutual decision that this matter must be concluded with the most rapid haste, and they have further agreed with the General that a totally uninterested third party be the link between both governments. This to allow for the honourable actions of both governments, as well as keeping the General in the background, and protecting the present recognized owner of the Cash Certificate of Deposit. At present all parties concerned recognize that the only legal owner of this Certificate of Deposit, Number 4051100-92 is Mr. Marlon Horn, Jr., a citizen and present resident of the United States of America, thru the U.S. Mortgage and Trust (Bahamas) Ltd., formally U.S.M.T., Inc./U.S. Mortgage and Trust Corporation, and therefore, this institution does confirm the above unconditionally.

with Horn is hard to understand, for we have no documentation that Horn is paying Ferrera, or that Ferrera is making any monies from his association with Horn. On the contrary, the partnership has cost Ferrera everything he could call his own. It appears that two opposites have been fated to meet for whatever reason, and each furnishes to the other what each needed. Ferrera seems to lead a charmed life, and all attempts to silence him, as ordered, have not been successful. We have orchestrated two attempts on the General within the past two years, failing in both. Now, none of our agencies can touch him, for he is under the protection of the White House. This agency feels that the Oval office knows that to cross the General would endanger the administration, but at the same time, they all agree that the General would take any blame for anything, rather than throw any shadows at the Presidency, as Colonel North was fast to do.

The Bureau has had as many as two dozen agents assigned to monitor all movements of Ferrera, but when he started to approach our agents and reprimand them for "terribly sloppy methods of trailing", we just decided to abort.

We cannot report why the Helms, duDaphne, Rothschild Cartel has not yet given the approval for Horn and his people to collect their funds. All the intelligence we can gather leads us to believe that it is all connected to the political situation in Japan, and that they are waiting for that to settle down before they allow the risk of release of the funds. That is the only manner of assuring themselves that the Japanese will play ball to the very end.

During the past year there have been 14 inquiries regarding the General, to various government agencies, and all can be traced to friends and/or associates of Marion Horn. We have taken all of our agents away from Marion Horn and all of his group and his "Trustees", as ordered by Justice, and we have destroyed all documentation pertaining to them, so in closing, we must add that other information to the Studebaker/Black Eagle affair must be obtained from the "non-existing files" of the CIA. We are sure that if the General does not exist, then there are no files.

Gregg knew the right man for the overseers job, Felix Rodriguez, a fanatically anti-communist Cuban exile who had worked for Gregg and the CIA in Vietnam. Rodriguez volunteered his services to battle the Sandinistas. Gregg deputized him to oversee the distribution of illegal arms to the Contras, primarily as a staging area in El Salvador. Both Gregg and Bush have since denied knowing anything of any illegal operations to arm the contras, until 1986, and it is unknown if Bush actually knew of Black Eagle. When Noriegas notoriety as a drug trafficker became widespread, the CIA concluded that it was time to put distance between him and the operation Black Eagle. Accordingly, a revised operation, code-name "Supermarket", was set into motion by Casey.

Noriega would have a small and non-direct role in the "Supermarket" operation. Micha Harare, the former Mossad operative, was to take full command. His contact was U.S. LtCol. Oliver North. North himself would prove to be naive, saying he did not know that the bulk of the money was from narcotics.

This is as much information as this Bureau has been able to obtain for the moment, Senator, for in-as-much as from the minute that General Ferrera decided to fully support the Kentucky group, all papers have disappeared. We feel that the CIA wanted everything shredded, because Ferrera had too many personal operatives, loyal only to him, and he would eventually find out about the full operation, as he did with Seal.

When General Ferrera had Seal eliminated, he inadvertently toppled the source of funds for the Contras; for like a domino theory, with Seal gone everyone started to look out for their own hides, and one thing led to another, until the discovery of the so-called Iran-Contra-North affair.

As stated before, it is impossible to secure any new information on General Ferrera, other than that which we enclose copies of...it is known, however, that as of this writing, the General is penniless, and still will not risk his government by allowing anyone to know of his dilemma. The connection

In 1976 this did not prevent CIA Director Gush from approving Noriegas' enrollment as a paid CIA asset....working directly for Armitage.

In 1977, a report detailing drug dealing by Noriega and other Panamanian Military officers was sent by General Ferrera to the White House, where it disappeared.

When Adm. Turner replaced Bush as CIA Director, he dropped Noriega from the Agency's payroll, but the Panamanian was restored to the Agency's good graces when the Reagan administration came into office. General Ferrera and Spadafora continued to complain to the CIA about Noriega until Noriega found out about it from Casey in 1985. Noriega had Spadafora tortured to death, then dumped his body in a U.S. mail sack and mailed it to General Ferrera in Mexico

City. This was Noriegas way of making a point. Ferrera, it is rumored, went under-cover, on his own, into Panama, and somehow made his way into the compound of General Noriega. There, in the General's own bedroom, General Ferrera is said to have accosted Noriega, bound him up and personally cut off the testes of Noriega. Then he stuffed the testes into Noriegas mouth. The bureau recorded the incident in its entirety, and the voices, with our hidden mikes, but somehow this whole documentation has disappeared from our vaults. The General injected Noriega with a full dose of Cocain and left him bound in a drug stupor. It is believed this is the cause of Noriegas cocaine addiction. Noriega cannot inform anyone because he would have to tell all that he is not "Macho", and he lives in constant fear of Ferrera. He has even offered to make peace with Ferrera, but Ferrera has not paid attention to the overtures. Norieg, we have learned, revealed all about the Black Eagle operation to Castro.

This Bureau has raised the question of how much then V.P. Bush knew about the operation, especially Noriegas involvement. Our documentation is ambiguous, but a central fact is that Casey, concerned that the operation be as far removed from the CIA as possible, hit upon the idea of using the vice presidents office as a cover, arranging it via Bush's Chief of Staff, Donal Gregg, a former CIA officer.

In return, Noriega was able to offer the Israelis the use of Panama....The Vienna of International intrigue in the Southern Hemisphere...as a conduit for embargoed arms to Israel.

When Casey sought out Harare in 1982 to help set up a covert contra support operation, the Israeli knew the perfect point man for the job...Noriega. He was now a General, and the most powerful man in Panama. At that point, Casey had been given secret intelligence reports gathered by the private "intelligence army" of General Ferrera, telling Casey, with proof, that Noriega was a full fledged drug trafficker, allowing Panama to be used as a narcotics trans-shipment point. The CIA could not allow this report from Ferrera to be seen, so Casey contacted Ferrera, and offered to make him his second in command in the Agency. Ferrera turned it down stating that he was going to commence to back off, so as to retire....later, we intercepted a conversation between Ferrera and Helms, in which Ferrera stated that when Casey offered him something that big, there must be a reason for it, so he turned it down. Ferrera had his own "mole" with the government of Panama, Dr. Hugo Spadafora, Panamas vice-minister of Health, under dictator Omar Torrijos, also a friend of the Generals. Following the "unexplained" death of Torrijos in a plane crash, Spadafora at first allied himself with Noriega, then learned from Ferrera that Noriega was playing all sides of the street and into drug smuggling. Spadafora found out that Noriega was being paid \$250,000 per year by Casey as an asset for the CIA, while at the same time he was providing information to Fidel Castro, and worse, NORIEGA WAS DEEPLY INVOLVED IN THE DRUG TRAFFIC into the United States. This Bureau has copies of all documentation to substantiate all information contained herein.

All of the above came to the attention of Helms, who did not know who was playing for whom. The only person that he felt placed the country above his personal gain was General Ferrera, so he enlisted the help of the General in digging everything out.

The General found out, with Spadafora, that as early as 1972 the CIA was aware that Noriega had been named in a Federal Drug enforcement report as a trafficker.

the operation, only this time it had to be put under the control of Armitage, With the full knowledge of Bush, but not of President RR, nor of now Gen. Ferrera. Ferrera had to be kept in the dark because of his total aversion to the drug trade. He was assigned to other missions by the agency as a way to keep him in the dark. Lt. Colonel Oliver North was brought in to run the operation. History has now proven that Colonel North was no General Ferrera.

To avoid any risk, Helms had to stop the sale of the CD. Fortune smiled on Helms, for the Horn group did not follow the precise manner of cashing the instrument, trying to do it in a rather hap-hazard manner. This gave the door so Iizuka could be accused, along with the Horn people, of having "stolen" the CD, and thus, have all papers confiscated and everyone (except Iizuka, who was a participant with the government) be lost in jails in the Far East forever. No trace.....no records. This would have been successful, except that as yet unknown persons came to the aid of Horn and he was allowed to leave. The Mitsui Bank and the Japanese government officially declared the instrument to be a stolen "Blank" and thus a forgery, and on 21 November of 1983, all was confiscated from one John Burns and Horn. This was carried out by the Commercial Crime Division of the Singapore CID, by the Chief Inspector, Chai Yong sSong.....at least that is what the records that we have copied show. At this point, Senator, how much is fact and how much is fiction is hard to tell....But, we believe that the records in our possession pretty much prove that all is about as close to fact as is possible in something like this.

As we have stated before, mistakes have been made by the Helms people, but not as major as allowing Armitage to be in charge of the continuation of Eagle II. The name was changed for the new operation to "Golden Triangle", because none of the contacts established by General Ferrera for the purchase of the drugs could be used because the General would become aware of the situation, and thus he could blow the lid off the government participation. Again, present history now shows us that Armitage became the consummate double dealer, and the perfect "triple-crosser". We have documentation that we have bought showing

that Helms and the CIA are in possession of all the proof needed on the actions by Armitage. This Bureau estimates that Armitage has amassed a sum in excess of one hundred billion dollars. Our agents within the Oval Office inform us that they suspect that Armitage has invested all in Gold, and that the gold is deposited in various countries of the Pacific Rim. We will try to obtain full confirmation on this for you, Senator.

Now, when all of the papers and documentation from Horn were given to Inspector Chai, by one John Burns, the Japanese government put all to one side, waiting for a future date to once again try the operation "clean-up". It was felt that at a future time, Mr. Marion Horn could again be used as the buyer, and thus the washer of the funds. We were constantly kept informed by our paid informant in the Far East, Mr. William Sim Meng Lyang, aka Bill Sim. Since that time, all concerned have been silenced in one manner or another, even to include a fringe player, one Fajr Hamid Pacha, now in Federal custody.

All would have worked to perfection, but Mr. Marion Horn felt that he was in too deep, and he had to do something to keep the wolves off his back, so he started to move every rock in the hope that the action would enable him to keep his head above water. Mr. Horn used the bad judgement of entrusting a former agency man (on the lowest ladder of the organization), who had been let go because of his mental instability and lack of trustworthiness, to "investigate" with the State department. This individual has proven to be of the perfect type to use as an informant, and we have so used him from time to time, to obtain information on all that Horn and his group are doing. We simply have people say to him that they are CIA agents and they need his help, and he spills. His name is John Binette, and the last known address in our files on him is listed as 60 Adams Street, Biddeford, Maine. This individual was assigned by Horn to visit State. The records at State show that a John Binette did in fact visit, but he spoke only to a receptionist and to a guard, one Timothy Hamilton, no longer at State. Hamilton heard the saga, and without seeing any of the documentation to better guide Binette, stated that if Ms. Lide had attested to the validity of the CD then it must be real. Again, remember the wording on the consular validation. This was also followed by the filing of a claim against the United States

Department of State, seeking the return of the CD, as the rightful property of U.S. Mortgage and Trust Co., Inc. A very respected attorney here in Washington, and a personal friend of mine, Willard C. McBride, was obtained by Horn to render a legal opinion on this whole matter, and he, McBride, is fully convinced of the validity of the U.S. Mortgage claim. We are positive that McBride is unaware of the real truth of this matter, and also that all documentation no longer exists. Any "copies" in the possession of anyone can be claimed to be fakes.

Horn started to make too many waves and he enlisted the help of many influential individuals, including a friend of the Director of the Bureau, Mr. Alan Woolly. A decision was made, and that decision was that Marion Horn, Jr., and the U.S. Mortgage and Trust Co., had to be stopped, and to this end, the agency used our informant, Binette, as a tool to set up Mr. Horn, and in so doing, discredit Horn in the International financial community, by having Horn included in the "non-grata" book of Interpol and the World Banks. Until recently, Horn's name appeared in that book, but as of this report, we find that the name has totally been erased from new issues and all Interpol agencies and banks have been informed that it was an error to list Mr. Horn in the first place. (Senator Kennedy, this has the hand of Mr. Helms in it, for only he has the power to have this done world-wide).

As stated before, it was decided that Mr. Horn must be silenced, but without personal harm, for Helms felt that Horn actually believed he was within his rights. However, he had to be silenced, and the best manner of so doing was to fully discredit him. It was decided to bring in the General and tell him that this "J.R. HORN" was trying to cheat the government of the funds that were obtained by the Eagle II project, and the Mr. Horn was an agent of the Federal Bureau of Investigation. General Ferrera had to be used because he was the only link that was trusted by the powers in Singapore, under the leadership of Ed Ong, and by the powers in Japan. Ferrera agreed to personally get all of the information needed to "put Horn away", and for this it was arranged to have Horn and Ferrera meet. How this was finally accomplished, this Bureau has not been able to as yet confirm.

Ferrera started his investigation, using his world-wide contacts and private organization of intelligence, and during his findings he also started to discover the names of our agents within the CIA, as well as our agents in the U.S. Embassies abroad. He started to feed that information, along with the documentation, to a very good friend of his, William Casey, who had taken over the Agency from Adm. Turner in 1981. Per the orders of the former director, we set out to destroy any credibility that General Ferrera might have in this regard. We used paid informants and "runners" plus a plant, to attempt this. We forged the name of my friend, McBride, as well as other signatures and documents, in an attempt to show that the General was trying to sell the CD for his own personal gain, and that the General was not the "lily-white" patriot all thought him to be. We used three people in this respect, all of them former felons that had been aided back on their feet by Ferrera, thus, he trusted them. We paid for the transport to Kentucky to show the "evidence" to Horn. We have never been sure as to why this mission of ours failed, but it did, and the General doubled his efforts to "destroy" Horn, for now he was sure that Horn was using all means to get Ferrera off the case for the Bureau.

Now all took a turn in favor of Helms, duDaphne, Rothschild, and strange as it may seem, Marion Horn. This came about because Ferrera kept digging and digging, and the more he dug, the more he became convince that Horn was an innocent victim who had been used by the agency (which was true), and that Horn was as big a "Red, White and Blue" patriot as could be found. Ferrera was by now convinced that Horn was simply a super entrepenuer who had managed to out-hustle the hustlers. We have no idea, nor have we found any documentation that will show us why a hard-boiled General like Ferrera would suddenly look upon someone like Horn as a Son that had to be protected from the "mean guys", but that appears to be what has happened. We have copies of expenditures by Ferrera as well as his bank statements, that show us that he has used over half-million of his personal funds to buy gifts worth tens and tens of thousands of dollars and given them to people like Ed Ong, Baron deMonchey, 3 Prime Ministers of Japan, and others, such as the speaker of the House of Commons in England, telling them all that the gifts were sent to them by Marion Horn, thanking them for their efforts

in seeking out the truth and reaching a solution to the "Studebaker" matter. Ferrera in fact, did find the perfect solution that allowed all to save "FACE", wash the funds and pay Horn.

This matter has now been resolved, we are informed by Binette, and Horn is within weeks, if not days, of obtaining all of the funds...repeat....all of the funds from the CD, and Binette further informs us that all IRS taxes have been forgiven to a phony front trust, called "Five Star Trust", that has been set up as a cover for Horn. The Bureau has tried to investigate this, as well as investigate Horn's present workings, but as in the case of Ferrera, we have met with stone walls, and the orders have now come down directly from Justice and State that Horn and Ferrera are to be considered "untouchables", and all inquiries regarding them are to be stopped immediately, as well as all of the documentation in our files being shredded. This has been done, but we have not done so until this report was completed for you, Senator. There was a third name added to the "protected" list, that of the accountant for Mr. Horn, one William Clancy. In closing this part of the Studebaker report, we must sadly state that our main source of information, Binette, is so fearful now of the General that he has informed us that he will no longer cooperate with us, and that he will side with the General. It seems that the General ordered that a "fright" be put into Binette, in the form of a slight heart attack solution, and Binette feels that if he does not cooperate with Horn and the General, the attack will become fatal. He is probably correct. The man is truly a coward.

In the meantime, Casey had begun to look upon himself as a demi-god, and knowing that the agency had to have funds for Col. North, he started to get very careless. Files that we have obtained show that without consulting Helms, Casey set about establishing his own kingdom, with him as the emperor. He obtained help from the very depths of society, and put one Adler Berriman Seal in command of the drug road to obtain the funds for the North operation with the Contras. The agency had used Seal since 1981, as a contact man.

OBJECTIVES. Our documents show further that Casey ordered the subordination of drug enforcement to the goal of overthrowing Nicaraguas Sandinista government. Our information tells us that he allowed two Southern states to be used as major distribution points for Latin American narcotics, then he interfered with all attempts by local Police, and with our own FBI Agents to eradicate the problem.

Adler Berriman Seal was the most important organizer, facilitator, and impresario of the partnership between the CIA and organized crime. Seal earned over thirty million as his share of the drug smuggling, but what he loved more than money was the fact that he knew that we could not touch him, nor could any other agency of the United States. He loved to play the role of the back-slapping good "old boy" from Baton Rouge, and he loved flying.

Seal first encountered General Ferrera in early 1972, when he attempted to make money by helping the organizations dedicated to overthrowing Fidel Castro. He emerged as a partner with one group with headquarters in Mexico. Seal agreed to smuggle seven tons of C-4 explosives to the Mexican base, from which General Ferrera was preparing to dispatch teams of saboteurs into Cuba. Ferrera had heard of Seal, and did not like him, so he had Seal arrested "for violating the neutrality act", and yet, the case against Seal was thrown out by the Court. It was with the help of the operative in the exile group, who were CIA assets. They needed the flying expertise of Seal, and also, he had become a favorite of Casey. Seal was given the funds to establish his aviation consultant business in Latin America, and he ran across William R. Reeves, whom we have in our files as a notorious narcotics trafficker who specialized in smuggling huge loads of marijuana from Colombia in the U.S. The CIA had full knowledge of Seal's total actions. He ran guns to the contras for Casey, and he always was found innocent of any accusations in the courts.

While all of this transpired, the CIA had to establish a connection with the king-pins of Columbian cocaine, for money was badly needed by North. Seal was ordered to make contact with the Medellin Cartel, and he was most successful in this. Pablo Escobar, Jorge Ochoa and Carlos Lehder wanted to smuggle in tons

came to the fore when he inadvertently stepped on the toes of Casey and almost destroyed the Contra movement. The General got wind that a second rate hoodlum, once a member of the CIA, was involved in the importation of all drugs into the United States. It appears that Ferrera had some "spare" time on his hands, so he asked some of his friends to do something about "El Gordo". Seal. He did not know, and if he did know he did not care, that Adler Berriman Seal, El Gordo, was in fact working for Director Casey, and was responsible only to Casey, and that by asking that Seal be "fixed" he was risking the toppling of the money-machine for Col. North. Never-the-less, our tapes of phan conversations to the office of Director Casey show that General Ferrera informed him that he had information showing who the real leader of the drug cartel in the U.S. was, and that he wondered if he, Ferrera, would step on anyones toes if he stopped that "fat son-of-a-bitch". Director Casey answered that no, he was not working for the Agency. Thirty seconds after the General concluded his call, Director Casey called Helms and informed him of the conversation. Helms was very upset with Casey, and ordered him to clean up his act or suffer the consequences. This order angered Casey, and he attempted to contact Seal, but he was not very successful. In the meantime, the Generals' men were successful.

On the evening of February 19, 1986, at precisely 6:00 P.M., Adler Berriman Seal got out of his White cadillac in the parking lot of his favorite restaurant in Miami. The General had his men hiding behind a dumpster. Seal took no precautions, and he did not see the waiting men as he backed into a parking spot. The men approached, according to witnesses, the drivers side. There were two quick bursts from the silence equipped MAC-10 and from an UZI sub-machine gun. 96 bullets smashed into Seals head and body. He was dead instantly. The Bureau has copies of all tapes of all conversations with Casey, as well as copies of all police reports.

Our documents show that as Director of the CIA, William J. Casey, without approval of Helms went into business with drug smugglers, allowing tons of narcotics to enter the country as a necessary cost of higher geo-political

Nicaraguan problem. Congress was also about to cut off the money.

To prepare for that eventuality, Casey decided on secret operations to keep the anti-sandinista forces, Contras, armed and supplied. With a need for strict secrecy in order to circumvent the law, Casey set about creating an operation that could not be traced back to the CIA. He copied the original guidelines of the "Five", known as Eagle II, down to the very last period. The only difference was that the people in charge were not the qualified Five. Casey even went so far as to name the operation "Eagle", but when Helms heard rumors of an operation called "Eagle", he asked Armitage if he was involved. The answer was negative, but we intercepted a conversation between Armitage and Casey in which Casey was informed of the suspicions of Helms. Casey changed the name to "Black-Eagle". The operation proceeded through a Casey confidant, Micha Harare. Harare was the former head of operations in Central America for Mossad, Israel's CIA. Harare was a man steeped in the darker arts of modern espionage. He often stated that the "Eagle, Ferrera", was the only man in the world that he feared, but that he was better than the Eagle because he could "pull the trigger". Beginning in 1972, Harare was a key operative for Mossad murder squads that rampaged throughout Europe, killing key Palestinian guerrillas believed to be responsible for the slaughter of Israeli athletes at the 1972 Summer Olympics in Munich. In 1975, Harare's hit team killed an innocent man in error, and Harare was exiled to Mexico City as Chief of Mossad's Central American Operations.

Harare left the Israeli Intelligence service in 1978. In the interim, however, he had not only established close relations with the CIA, he had also forged important business contacts, among them Colonel Noriega of Panama, who had worked closely with Mossad.

While serving as Mossad asset, Harare went into the import-export business in Panama City. The link with his former agency was able to arrange twenty million worth of Israeli arms for the Panama military, plus Mossad training and Israeli made Uzi sub-machine guns for Noriega's Intelligence operatives.

of cocaine in single shipments, instead of hundreds of kilos by individual runners. Along came Seal with his airline, that in truth was the Casey airline. He established the perfect system for smuggling tons of cocaine....Now, Casey contacted a corrupt Colonel in the Panamanian Defense Forces, a Colonel that Casey had had on the CIA payroll. This Colonel was named Manuel Noriega, and he was the head of the Panamanian Defense Forces Intelligence Unit. Thus Noriega controlled a network of out of the way landing strips in Panama that he agreed to provide for the partners, Lehder and Seal. In return, Noriega was to receive a \$500,000.000 cash bribe plus a one percent cut of the value of every shipment that came through Panama. Additionally, Panamas banking laws would be used by the CIA to launder the Medellin drug profits, in return for another slice to Noriega. Finally, Casey had to agree to do all in his power to arm Noriega and clandestinely see that Noriegas' foes were eliminated so that Noriegas' ambitions to become President of Panama could be reached.

This whole operation was the brain child of CIA Director Casey. As Casey saw the problem, the Soviet Union was about to establish a Central American beachhead via the Sandinista government of Nicaragua. The only solution was to eliminate the Sandinista regime. Since an out-right American military invasion was out of the question, and since the only CIA man who was a personal acquaintance of Noriega was General Ferrera, and since General Ferrera would not agree to drug smuggling in the the U.S., Casey began to formulate plans for a covert paramilitary operation to accomplish the task. However, to do this, he needed Ferrera. Thus, he first tried to break Ferrera, by giving us fake information and planting fake records in various parts of the country, with the idea to offer to "clean it up", if Ferrera took command of the paramilitary group.

Essentially the plan was simple. Two groups of nicaraguan exiles--one based in Honduras and the other in Costa Rica--would be armed and trained for a Guerilla war inside Nicaragua that would eventually topple the regime. The difficulty was that congress was extremely nervous about the operation and questions were being asked whether an American sponsored war was the right way to solve the

Lets Not Forget: Bush Planned Iraq 'Regime Change' Before Becoming President

15 September 2002: A SECRET blueprint for US global domination reveals that President Bush and his cabinet were planning a premeditated attack on Iraq to secure 'regime change' even before he took power in January 2001.

The blueprint, uncovered by the Sunday Herald, for the creation of a 'global Pax Americana' was drawn up for Dick Cheney (now vice- president), Donald Rumsfeld (defence secretary), Paul Wolfowitz (Rumsfeld's deputy), George W Bush's younger brother Jeb and Lewis Libby (Cheney's chief of staff). The document, entitled *Rebuilding America's Defences: Strategies, Forces And Resources For A New Century*, was written in September 2000 by the neo-conservative think-tank Project for the New American Century (PNAC).

The plan shows Bush's cabinet intended to take military control of the Gulf region whether or not Saddam Hussein was in power. It says: 'The United States has for decades sought to play a more permanent role in Gulf regional security. While the unresolved conflict with Iraq provides the immediate justification, the need for a substantial American force presence in the Gulf transcends the issue of the regime of Saddam Hussein.'

The PNAC document supports a 'blueprint for maintaining global US pre-eminence, precluding the rise of a great power rival, and shaping the international security order in line with American principles and interests'.

This 'American grand strategy' must be advanced for 'as far into the future as possible', the report says. It also calls for the US to 'fight and decisively win multiple, simultaneous major theatre wars' as a 'core mission'.

The report describes American armed forces abroad as 'the cavalry on the new American frontier'. The PNAC blueprint supports an earlier document written by Wolfowitz and Libby that said the US must 'discourage advanced industrial nations from challenging our leadership or even aspiring to a larger regional or global role'.

The PNAC report also:

I refers to key allies such as the UK as 'the most effective and efficient means of exercising American global leadership';

I describes peace-keeping missions as 'demanding American political leadership rather than that of the United Nations';

I reveals worries in the administration that Europe could rival the USA;

I says 'even should Saddam pass from the scene' bases in Saudi Arabia and Kuwait will remain permanently -- despite domestic opposition in the Gulf regimes to the stationing of US troops -- as 'Iran may well prove as large a threat to US interests as Iraq has';

I spotlights China for 'regime change' saying 'it is time to increase the presence of American forces in southeast Asia'. This, it says, may lead to 'American and allied power providing the spur to the process of democratisation in China';

I calls for the creation of 'US Space Forces', to dominate space, and the total control of cyberspace to prevent 'enemies' using the internet against the US;

I hints that, despite threatening war against Iraq for developing weapons of mass destruction, the US may consider developing biological weapons -- which the nation has banned -- in decades to come. It says: 'New methods of attack -- electronic, 'non-lethal', biological -- will be more widely available ... combat likely will take place in new dimensions, in space, cyberspace, and perhaps the world of microbes ... advanced forms of biological warfare that can 'target' specific genotypes may transform biological warfare from the realm of terror to a politically useful tool';

I and pinpoints North Korea, Libya, Syria and Iran as dangerous regimes and says their existence justifies the creation of a 'world-wide command-and-control system'.

Tam Dalyell, the Labour MP, father of the House of Commons and one of the leading rebel voices against war with Iraq, said: 'This is garbage from right-wing think-tanks stuffed with chicken-hawks -- men who have never seen the horror of war but are in love with the idea of war. Men like Cheney, who were draft-dodgers in the Vietnam war.

'This is a blueprint for US world domination -- a new world order of their making. These are the thought processes of fantasist Americans who want to control the world. I am appalled that a British Labour Prime Minister should have got into bed with a crew which has this moral standing.'
