

	1694	The "City of London" refers to a historical and financial district located in the heart of London, England. It is often referred to as the "Square Mile" because of its approximate area of one square mile (2.6 square kilometers). The City of London is one of the 33 boroughs of Greater London but holds a unique status as a distinct ceremonial and financial center. The City of London has a rich history dating back to Roman times when it was originally founded as a settlement called Londinium. Over the centuries, it has grown into a prominent financial hub and the primary financial district of the United Kingdom. It is home to the Bank of England, the London Stock Exchange, numerous international banks, insurance companies, and financial institutions. Despite its small size, the City of London holds considerable influence in global finance and commerce. It has its own governing body, the City of London Corporation, which is responsible for the local administration and maintaining the district's unique status. Additionally, the term "City of London" can sometimes be confused with "London" itself, which refers to the larger metropolitan area encompassing numerous boroughs and neighborhoods, including the City of London.	
	February 21, 1871	Washington D.C. was created as an independent City-State with The Organic Act of 1871. Washington, D.C. represents the southern point of the Northeast megalopolis, one of the nation's largest and most influential cultural, political, and economic regions that runs along its northeastern coast from Boston in the north to Washington, D.C. in the south and include New York City, Philadelphia, and Baltimore. As the seat of the U.S. federal government and several international organizations, the city is an important world political capital. It is the eighth-most visited city in the U.S. with over two million visitors as of 2019.	
	February 11, 1929	Vatican City was established in its current form as a sovereign nation with the signing of the Lateran Pacts. It is a distinct territory under "full ownership, exclusive dominion, and sovereign authority and jurisdiction" of the Holy See, itself a sovereign entity under international law, which maintains the city state's temporal power and governance, diplomatic, and spiritual independence.	
	May 17, 1930	The Bank for International Settlements (BIS) is an international financial institution that is owned by member central banks. Its primary goal is to foster international monetary and financial cooperation while serving as a bank for central banks. Before the US, Belgium, and France decided to sell all or a portion of the shares assigned to their central banks to private investors, the BIS was initially owned by both central banks and private individuals. Despite officially being an international organization under public international law, the BIS was able to permit private shareholders because its shares were listed on stock exchanges. Several central banks also started as privately owned businesses, similar to how the Bank of England was until 1946. Recent events have seen

	the BIS repurchase its previously traded shares. The BIS members currently own it wholly, but it still serves as a counterparty, asset manager, and lender in the private market.
July 1, 1944	Bretton Woods System was created. The Bretton Woods Conference, also known as the United Nations Monetary and Financial Conference, was an event that brought together 730 delegates from all 44 allied nations at the Mount Washington Hotel in Bretton Woods, New Hampshire, in order to establish rules for the post-World War II monetary and financial order.
July 4, 1944	The World Bank was created. The World Bank is an international financial institution that provides loans and grants to the governments of low- and middle-income countries for the purpose of pursuing capital projects. The World Bank is the collective name for the International Bank for Reconstruction and Development (IBRD) and International Development Association (IDA), two of five international organizations owned by the World Bank Group. It was established along with the International Monetary Fund at the 1944 Bretton Woods Conference. After a slow start, its first loan was to France in 1947.
October 24, 1945	The United Nations was founded. The United Nations, referred to informally as the UN, is an intergovernmental organization whose stated purposes are to maintain international peace and security, develop friendly relations among nations, achieve international cooperation, and serve as a center for harmonizing the actions of nations. It is the world's largest international organization. The UN officially came into existence when the Charter was ratified by the required number of member states. This date is now celebrated annually as United Nations Day. The UN is headquartered in New York City (in the United States, but with certain extraterritorial privileges), and the organization has other offices in Geneva, Nairobi, Vienna, and The Hague, where the International Court of Justice is headquartered.
December 27, 1945	The International Monetary Fund (IMF) was created. The International Monetary Fund (IMF) is a major financial agency of the United Nations, and an international financial institution, headquartered in Washington, D.C., consisting of 190 countries. Its stated mission is "working to foster global monetary cooperation, secure financial stability, facilitate international trade, promote high employment and sustainable economic growth, and reduce poverty around the world.
April 7, 1948	The World Health Organization was founded. The World Health Organization (WHO) is a specialized agency of the United Nations responsible for international public health. It is headquartered in Geneva, Switzerland, and has six regional offices and 150 field offices worldwide.
March17, 1948	The European Union (EU) was formed. The European Union (EU) is a supranational political and economic union of 27 member states that are located primarily in Europe. The union has a total area of 4,233,255 km2 (1,634,469 sq mi) and an estimated total population of over 448 million.
May 14, 1948	The modern State of Israel was officially formed. The establishment of Israel came after the adoption of the United Nations General Assembly Resolution 181, known as the "UN Partition Plan for Palestine," in November 1947. According to Isaiah, "[God] will assemble the outcasts of Israel and gather the dispersed of Judah from the four corners of the earth" and allow them to return to their ancestral homeland. Today, there are Jews in every corner of the world, and increasing numbers of them have returned to live in Israel. In a mere 70 years, the Jewish population of Israel has grown from 500,000 to over 7 million.
April 4, 1949	The North Atlantic Treaty Organization (NATO) was established. The North Atlantic Treaty Organization (NATO), also called the North Atlantic Alliance, is an intergovernmental military alliance between 31 member states – 29 European and two North American. Established in the aftermath of World War II, the organization implemented the North Atlantic Treaty, signed in Washington, D.C., on 4 April 1949. NATO is a collective security system: its independent member states agree to defend each other against attacks by third parties. During the Cold War, NATO operated as a check on the threat posed by the Soviet Union. The alliance remained in place after the dissolution of the Soviet Union and the Warsaw Pact, and has been involved in military operations in the Balkans, the Middle East, South Asia, and Africa.
May 25, 1963	The African Union (AU) was established. The African Union (AU) is a continental union consisting of 55 member states located on the continent of Africa. The AU was announced in the Sirte Declaration in Sirte, Libya, on 9 September 1999, calling for the establishment of the African Union.
January 24, 1971	The World Economic Forum (WEF) is established. The World Economic Forum (WEF) is an international non-governmental and lobbying organization for multinational companies based in Cologny, Canton of Geneva, Switzerland. It was founded on 24 January 1971 by German engineer Klaus Schwab. The foundation, which is mostly funded by its 1,000 member companies – typically global enterprises with more than US\$5 billion in turnover – as well as public subsidies, views its own mission as "improving the state of the world by engaging business, political, academic, and other leaders of society to shape global, regional, and industry agendas".

May 1, 1975	The Vanguard Group, Inc. was founded . The Vanguard Group, Inc. is an American registered investment advisor based in Malvern, Pennsylvania, with about \$7.7 trillion in global assets under management, as of April 2023.
1985	Blackstone Inc. was founded. Blackstone Inc. is an American alternative investment management company based in New York City. Blackstone's private equity business has been one of the largest investors in leveraged buyouts in the last three decades, while its real estate business has actively acquired commercial real estate. Blackstone is also active in credit, infrastructure, hedge funds, insurance, secondaries, and growth equity. As of Q1 2023, the company's total assets under management were approximately US \$991 billion, making it the largest alternative investment firm globally.
1988	BlackRock, Inc. was founded. BlackRock, Inc. is an American multinational investment company based in New York City. Founded in 1988, initially as an enterprise risk management and fixed income institutional asset manager, BlackRock is the world's largest asset manager, with US \$8.59 trillion in assets under management as of December 31, 2022. BlackRock operates globally with 70 offices in 30 countries and clients in 100 countries.
September 9, 1999	The African Union (AU) was established. The African Union (AU) is a continental union consisting of 55 member states located on the continent of Africa. The AU was announced in the Sirte Declaration in Sirte, Libya, on 9 September 1999, calling for the establishment of the African Union.
December 8, 2004	The Union of South American Nations (USAN) was formed. The Union of South American Nations (USAN), [a] sometimes also referred to as the South American Union, abbreviated in Spanish as UNASUR and in Portuguese as UNASUL, is an intergovernmental regional organization set up by Hugo Chavez to counteract the influence of the United States in the region. It once comprised twelve South American countries; as of 2019, most have withdrawn.
2005	The North American Union (NAU) was established. The North American Union (NAU) is a theoretical economic and political continental union of Canada, Mexico and the United States, the three largest and most populous countries in North America. The concept is loosely based on the European Union, occasionally including a common currency called the amero or the North American Dollar. In 2005, claims emerged from critics of North American integration that a "North American Union" was not only being planned, but was being implemented by the governments of Canada, Mexico, and the United States.

Vatican City


The Lateran Pacts, which were signed on February 11, 1928, gave Vatican City its modern status as a sovereign state. It is a distinct area under the "complete ownership, exclusive dominion, and sovereign authority and jurisdiction" of the Holy See, which upholds the city state's temporal power and governance, diplomatic independence, and spiritual independence as a sovereign body under

international law. Rome or Italy do not include Vatican City. The Vatican is the only authentic part of the Roman Empire left today. The Vatican is in charge of around 3 billion of the 7 billion people on the earth.

The Vatican has made large investments with the Rothschilds in Britain, France, and the United States, and with massive oil and weapons companies like Shell and General Electric. The Rothschild-controlled Bank of England and the US Federal Reserve Bank are the storage locations for the Vatican's solid gold bullion, which is worth billions.

The Catholic Church is the largest financial force, wealth accumulator, and property owner in history, holding more significant wealth than any bank, company, huge trust, or government anywhere in the world. The Vatican hoards the world's riches, profits from it on the stock market, and simultaneously preaches about giving, while 2/3 of the world's population earns less than \$2 per day and 1/5 is underfed or starving to death. How then did the Vatican amass all that money throughout the centuries?

One strategy was to assign a cost to sin. By peddling

The City of London

The City of London has a rich history dating back to Roman times when it was originally founded as a settlement called Londinium. Additionally, the term "City of London" can sometimes be confused with "London" itself, which refers

to the larger metropolitan area encompassing numerous boroughs and neighborhoods, including the City of London. Like Vatican City, London's inner city is also a privately owned corporation or city-state, located right in the



middle of greater London. It became a sovereign state in 1694 when King William III of Orange privatized and turned the Bank of England over to the bankers.

Today, the City State of London is the world's financial power center and the wealthiest square mile on the face of the Earth. It houses the Rothschild-controlled Bank of England, Lloyds of London, the London stock exchange, all British banks, the branch offices of 385 foreign banks, and 70 US banks. It has its own courts, its own laws, its own flag, and its own police force. It is not part of greater London, England, or the British Commonwealth and pays no taxes.

The City State of London houses Fleet Street's newspaper & publishing monopolies. It is also the headquarters for worldwide English Freemasonry & headquarters for the worldwide money cartel known as The Crown. Contrary to popular belief, The Crown is not the Royal Family or the British Monarch. The Crown is the private corporate City State of London. It has a council of 12 members who rule the corporation under a mayor, called the Lord Mayor. The Lord mayor and his 12-member council serve as proxies or representatives who sit in for 13 of the world's wealthiest, most powerful banking families, including

the Rothschild family, the Warburg family, the Oppenheimer family & the Schiff family. These families and their descendants run the Crown Corporation of London. The Crown Corporation holds the title to worldwide Crown land in Crown colonies like Canada, Australia, and New Zealand. British parliament and the British prime minister serve as a public front for the hidden power of these ruling crown families.



Washington D.C.

A third city-state was formally established in 1791, joining the City States of London and the Vatican. On 68 square miles of territory in the center of Washington, there is a city-state called the District of Columbia. The District of Columbia has its own autonomous constitution and flies its own flag. The District

of Columbia's constitution is governed by the oppressive Roman legislation known as Lex Fori, which bears no similarity to the US Constitution.

The United States was established as a separate corporation by Congress' passage of the Act of 1871, along with a corporate government for the District of Columbia. The District of Columbia was able to operate as a corporation outside of the terms of the original US Constitution and against the interests of American citizens because of this traitorous conduct. Since 1871, the US president and US Congress have played politics by a different set of principles and guidelines.

The existence of two separate constitutions in the US is unknown to the public. The first was written in 1776 by the governors of the United States' newly independent states. Liberty was established on July 4, 1776, when the people proclaimed their freedom from Britain. And the American people had 95 years



of freedom and independence. When the original "Constitution for the United States of America" was modified to "THE CONSTITUTION OF THE UNITED STATES OF AMERICA" in 1871, such freedom came to an end.

The Congress signed a financial arrangement with international financiers (at the time, the Rothschilds of London) after realizing the country was in severe financial circumstances, accruing a DEBT to those bankers in the process. Without certain strict conditions, the cunning foreign financiers were not going to lend the struggling country any money.

They, therefore, came up with a plan to regain power of the United States, and as a result, the Act of 1871 was passed. Congress established a distinct system of government for the District of Columbia despite not having the legal right to do so under the Constitution. With the passage of "the Act of 1871" a city state (a state within a state) called the District of Columbia located on 69 sq miles of land in the heart of Washington was formed with its own flag and its own independent constitution – the United States' secret second constitution. The flag of Washington's District of Columbia has 3 red stars, each symbolizing a city-state within the three-city-state empire. The three-city state empire consists of Washington D.C., London, and Vatican City.

London, the corporate capital of the three city-states, controls the world economy. The District of Columbia in Washington manages the armed forces on behalf of the city-state, while the Vatican, which claims to be a spiritual authority, governs the entire planet. Despite their geographical separation, the city-states of London, the Vatican, and the District of Columbia are referred to as the "Empire of the City" together. The restrictive "Lex Fori" of the Vatican controls the District of Columbia's constitution (local law). The Act of 1871, passed by Congress, created a corporate government for the District of Columbia as well as the United States as a separate

corporation. In defiance of the original United States Constitution, the District of Columbia can currently function as a corporation.



In DC city state, the phallic-shaped stone obelisk known as the Washington Monument was dedicated to the Freemason George Washington by the Freemason Grand Lodge of the District of Columbia. 250 Masonic lodges financed the Washington obelisk monument, including the Knights Templar Masonic order. The city-states of London, the Vatican, and the District of Columbia together make up the Empire of the City, despite their physical separation. The District of Columbia's flag features three red stars. Each city-state in the three-city empire had one. Through the financial might of London's inner city, the military might of the District of Columbia, and the spiritual influence of the Vatican, this corporate empire of three city-states rules over the entire planet.

The U.S.A. - A Crown Colony

A startling truth is revealed by a sobering analysis of the treaties and charters that Britain and the US have signed. The US has always been and continues to be a colony of the British Crown. King James, I was renowned for more than only creating the King James Version of the Bible. Nevertheless, Virginia's first charter was ratified in 1606.

After America declared its independence from

Great Britain, the Treaty of 1783 was signed. That treaty specifically identifies the King of England as the Prince of the United States and contradicts the belief that America won the War of Independence.

Although King George III of England gave up most of his claims over American colonies, he kept his right to continue receiving payment for his business venture of colonizing America. If America had really won the War of Independence, they would never have agreed to pay debts & reparations to the King of England. America's blood-soaked War of Independence against the British bankrupted America and turned its citizens into permanent debt slaves of the King.

In the War of 1812, the British torched & burned to the ground the Whitehouse & all US government buildings, destroying ratification records of the US Constitution. Most US citizens believe that the US is a country, and the President is the most powerful man on earth.

The US is not a country. It is a corporation. And the president is the President of the Corporation of the United States. He and his elected officials work for the corporation, not for the American people. Since the US is a corporation, who owns the corporation of the United States? Like Canada and Australia whose leaders are Prime Ministers of the Queen and whose land is called Crown Land, the US is just another crown colony. Crown colonies are controlled by the Empire of the 3 City States.

The Templars of the Crown

The governmental and judicial systems within the United States of America, at both federal and local state levels, is owned by the "Crown," which is a private foreign power. Before jumping to conclusions about the Queen of England or the Royal Families of Britain owning the U.S.A., this is a different "Crown" and is fully exposed and explained below. We are specifically referencing the established **Templar Church**, known for centuries by the world as the "Crown." From this point on, we will also refer to the **Crown** as the **Crown Temple** or **Crown Templar**, all three being synonymous.

First, a little historical background. The Temple Church was built by the **Knights Templar** in two parts: the **Round** and the **Chancel**. The Round Church was consecrated in 1185 and modeled after the circular Church of the Holy Sepulchre in Jerusalem. The Chancel was built in 1240. The **Temple Church** serves both the **Inner and Middle Temples** (see below) and is located between Fleet Street and Victoria Embankment at the Thames River. Its grounds also house the **Crown Offices** at Crown Office Row. This Temple "Church" is outside any Canonical jurisdiction. The **Master of the Temple** is appointed and takes his place by sealed (non-public) patent, without induction or institution.

All licensed Bar Attorneys - Attorners (see definitions below) – in the U.S. owe their allegiance and give their solemn oath in pledge to the Crown Temple, realizing this or not. This is simply due to the fact that all **Bar Associations** throughout the world are signatories and franchises to the international Bar Association located at the **Inns of Court** at Crown Temple, which are physically located at **Chancery Lane** behind Fleet Street in London. Although they vehemently deny it, all Bar Associations in the U.S., such as the American Bar Association, the Florida Bar, or California Bar Association, are franchises to the Crown.

The Inns of Court (see below, *The Four Inns of Court*) to the Crown Temple use the **Banking** and **Judicial** system of the **City of London** - a sovereign and independent territory which is *not* a part of Great Britain (just as Washington City, as DC was called in the 1800's, is *not* a part of the north American states, nor is it a state) to defraud, coerce, and manipulate the American people. These **Fleet Street bankers and lawyers** are committing crimes in America under the guise and color of law (see definitions for *legal* and *lawful* below). They are known collectively as the "Crown." Their lawyers are actually **Templar Bar Attornies**, *not* lawyers.

The present Queen of England is *not* the "Crown," as we have all been led to believe. Rather, it is the Bankers and Attornies (Attorneys) who are the actual Crown or Crown Temple. The Monarch aristocrats of England have *not* been ruling sovereigns since the reign of King John, circa 1215. All royal sovereignty of the old British Crown since that time has passed to the **Crown Temple in Chancery**.

The U.S.A. is not the free and sovereign nation that our federal government tells us it is. If this were true, we would not be dictated to by the Crown Temple through its bankers and attornies. The U.S.A. is controlled and manipulated by this private foreign power and our unlawful Federal U.S. Government is their pawn broker. The bankers and Bar Attorneys in the U.S.A. are a franchise in oath and allegiance to the **Crown at Chancery** - the Crown Temple Church and its **Chancel** located at Chancery Lane - a manipulative body of elite bankers and attorners from the independent City of London who violate the law in America by imposing fraudulent "legal" - but

totally unlawful - contracts on the American people. The banks **Rule** the Temple Church and the Attorners carry out their **Orders** by controlling their victim's judiciary.

Since the first **Chancel** of the Temple Church was built by the **Knights Templar**, this is not a new ruling system by any means. The Chancel, or **Chancery**, of the **Crown Inner Temple Court** was where King John was, in January 1215, when the English barons demanded that he confirm the rights enshrined in the Magna Carta. This City of London Temple was the headquarters of the **Templar Knights** in Great Britain where **Order** and **Rule** were first made, which became known as **Code**. Remember all these terms, such as <u>Crown</u>, <u>Temple</u>, <u>Templar</u>, <u>Knight</u>, <u>Chancel</u>, <u>Chancery</u>, <u>Court</u>, <u>Code</u>, <u>Order</u> and <u>Rule</u> as we tie together their origins with the present American Temple Bar system of thievery by equity (chancery) contracts.

"Woe unto you, scribes and Pharisees, hypocrites! for ye are like unto whited sepulchres, which indeed appear beautiful outward, **but are within full of dead men's bones**, and of all uncleanness." *-Matthew* 23:27

By what authority has the "Crown" usurped the natural sovereignty of the American people? Is it acceptable that the U.S. Supreme Court decides constitutional issues in the U.S.A? How can it be considered in any manner as being "constitutional" when this same Supreme Court is appointed by (not elected) and paid by the Federal U.S. Government? Is it any wonder the states and her people have no justice as they dwell upon the land? As you will soon see, the land called North America belongs to the Crown Temple.

The legal system (judiciary) of the U.S.A. is controlled by the Crown Temple from the independent and sovereign City of London. The private Federal Reserve System, which issues fiat U.S. Federal Reserve Notes, is financially owned and controlled by the Crown from Switzerland, the home and legal origin for the **charters** of the United Nations, the International Monetary Fund, the World Trade Organization, and most importantly, the Bank of International Settlements. Even Hitler respected his Crown bankers by not bombing Switzerland. The Bank of International Settlements in Basel, Switzerland controls *all* the central banks of the G7 nations. He who controls the gold rules the world.

The Four Inns of Court to the unholy Temple

Globally, all the legalistic scams promoted by the exclusive monopoly of the **Temple Bar** and their Bar Association franchises come from four Inns or Temples of Court: the <u>Inner Temple</u>, the <u>Middle Temple</u>, <u>Lincoln's Inn</u>, and <u>Gray's Inn</u>. These Inns/Temples are exclusive and private country clubs; secret societies of world power in commerce. They are well established, some having been founded in the early 1200's. The Queen and Queen Mother of England are current members of both the Inner Temple and Middle Temple. Gray's Inn specializes in Taxation legalities by Rule and Code for the Crown. Lincoln's Inn received its name from the Third Earl of Lincoln (circa 1300).

Just like all U.S. based franchise Bar Associations, none of the Four Inns of the Temple are incorporated - for a definite and purposeful reason: You can't make claim against a non-entity and a non-being. They are private societies without charters or statutes, and their so-called constitutions are based solely on custom and self-regulation. In other words, they exist as secret societies without a public "front door" unless you're a private member called to their Bar.

While the Inner Temple holds the legal system franchise by license to steal from Canada and Great Britain, it is the **Middle Temple** that has legal license to steal from America. This comes about directly via their Bar Association franchises to the **Honourable Society of the Middle Temple** through the Crown Temple.

From *THE HISTORY OF THE INN*, <u>Later Centuries</u>, [p.6], written by the Honourable Society of the Middle Temple, we can see a direct tie to the Bar Association franchises and its Crown signatories in America:

"Call to the Bar or keeping terms in one of the four Inns a pre-requisite to Call at King's Inns until late in the 19th century. In the 17th and 18th centuries, students came from the American colonies and from many of the West Indian islands. The Inn's records would lead one to suppose that for a time there was hardly a young gentleman in Charleston who had not studied here. Five of the signatories to the Declaration of Independence were Middle Templars, and notwithstanding it and its consequences, Americans continued to come here until the War of 1812".

All Bar Association licensed Attorneys must keep the terms of their oath to the Crown Temple in order to be accepted or "called to Bar" at any of the King's Inns. Their oath, pledge, and terms of allegiance are made to the Crown Temple.

It's a real eye opener to know that the Middle Inn of the Crown Temple has publicly acknowledged there were at least five Templar Bar Attornies, under solemn oath only to the Crown, who signed what was alleged to be an American Declaration of Independence. This simply means that both parties to the Declaration agreement were of the same origin, the Crown Temple. In case you don't understand the importance of this, there is no international agreement or treaty that will ever be honored, or will ever have lawful effect, when the same party signs as both the first and second parties. It's merely a worthless piece of paper with no lawful authority when both sides to any agreement are actually the same. In reality, the American Declaration of Independence was nothing more than an internal memo of the Crown Temple made among its private members.

By example, Alexander Hamilton was one of those numerous Crown Templars who was called to their Bar. In 1774, he entered **King's College** in New York City, which was funded by members of the London **King's Inns**, now named **Columbia University**. In 1777, he became a personal aide and private secretary to George Washington during the American Revolution.

In May of 1782, Hamilton began studying law in Albany, New York, and within six months had completed a three year course of studies, passed his examinations, and was admitted to the New York Bar. Of course, the New York Bar Association was/is a franchise of the Crown Temple through the Middle Inn. After a year's service in Congress during the 1782-1783 session, he settled down to legal practice in New York City as **Alexander Hamilton, Esqr**. In February of 1784, he wrote the charter for, and became a founding member of, the **Bank of New York**, the State's first bank.

He secured a place on the New York delegation to the Federal Convention of 1787 at Philadelphia. In a five hour speech on June 18th, he stated "an Executive for life will be an elective Monarch". When all his anti-Federalist New York colleagues withdrew from the Convention in protest, he alone signed the Constitution for the United States of America representing New York State, one of the legal Crown States (Colonies).

One should particularly notice that a lawful <u>state</u> is made up of the people, but a <u>State</u> is a legal entity of the Crown - a Crown Colony. This is an example of the deceptive ways the Crown Temple - Middle Templars - have taken control of America since the beginning of our settlements. This is explained in further detail below.

Later, as President Washington's U.S. Treasury Secretary, Hamilton alone laid the foundation of the first Federal U.S. Central Bank, secured credit loans through Crown banks in France and the Netherlands, and increased the power of the Federal Government over the hoodwinked nation-states of the Union. Hamilton had never made a secret of the fact that he admired the government and fiscal policies of Great Britain.

Americans were fooled into believing that the legal Crown Colonies comprising New England were independent nation states, but they never were nor are today. They were and still are **Colonies of the Crown Temple**, through **letters patent** and **charters**, who have no legal authority to be independent from the Rule and Order of the Crown Temple. A legal State is a Crown Temple Colony.

Neither the American people nor the Queen of Britain own America. The Crown Temple owns America through the deception of those who have sworn their allegiance by oath to the Middle Templar Bar. The Crown Bankers and their Middle Templar Attornies Rule America through unlawful contracts, unlawful taxes, and contract documents of false equity through debt deceit, all strictly enforced by their completely unlawful, but "legal", Orders, Rules and Codes of the Crown Temple Courts, our so-called "judiciary" in America. This is because the Crown Temple holds the land titles and estate deeds to all of North America.

The biggest lie is what the Crown and its agents refer to as "**the rule of law**". In reality, it is *not* about law at all, but solely about the Crown **Rule** of all nations. For example, just read what President Bush stated on November 13, 2001, regarding the "rule of law:"

"Our countries are embarked on a new relationship for the 21st century, founded on a commitment to the values of democracy, the free market, and the rule of law."

 $- Joint\ Statement\ by\ President\ George\ W.\ Bush\ and\ President\ Vladimir\ V.\ Putin\ on\ 11/13/01, spoken\ from\ the\ White\ House,\ Washington\ D.\ C.$

What happened in 1776?

"Whoever owns the soil, owns all the way to the heavens and to the depths of the earth." - Old Latin maxim and Roman expression.

1776 is the year that will truly live in infamy for all Americans. It is the year that the Crown Colonies became legal **Crown States**. The Declaration of Independence was a <u>legal</u>, <u>not lawful</u>, document. <u>It was signed on both sides by representatives of the Crown Temple</u>. Legally, it announced the **status quo** of the Crown Colonies to that of the new legal name called "States" as direct possessive **estates** of the Crown (see the definitions above to understand the legal trickery that was done).

The American people were hoodwinked into thinking they were declaring lawful independence from the Crown. Proof that the Colonies are still in Crown possession is the use of the word "State" to signify a **'legal estate of possession**." Had this been a document of and by the people, both the Declaration of Independence and the U.S. Constitution would have been written using the word "states". By the use of "State," the significance of a government of estate possession was legally established. All of the North American States are Crown Templar possessions through their legal document, signed by their representation of both parties to the contract, known as the Constitution of the United States of America.

All "Constitutional Rights" in America are simply those dictated by the Crown Temple and enforced by the Middle Inn Templars (Bar Attorners) through their franchise and corporate government entity, the federal United States Government. When a "State Citizen" attempts to invoke his "constitutional", natural, or common law "rights" in **Chancery** (equity courts), he is told they don't apply. Why? Simply because a <u>State citizen</u> has no rights outside of the **Rule** and **Codes** of Crown "law". Only a <u>state citizen</u> has natural and common law rights by the paramount authority of God's Law.

The people who comprise the citizenry of a state are recognized only within natural and common law as is already established by God's Law. Only a **State Citizen** can be a party to an action within a **State Court**. A common state citizen cannot be recognized in that court because he doesn't legally exist in Crown Chancery Courts. In order to be recognized in their State Courts, the common man must be converted to that of a corporate or legal entity (a legal fiction).

Now you know why they create such an entity using all capital letters within Birth Certificates issued by the State. They convert the common lawful man of God into a fictional legal entity subject to **Administration** by **State Rules**, **Orders** and **Codes** (there is no "law" within any Rule or Code). Of course, Rules, Codes, etc. do not apply to the lawful common man of the Lord of lords, so the man with inherent Godly law and rights must be converted into a legal "**Person**" of fictional "**status**" (another legal term) in order for their legal - but completely unlawful – State Judiciary (Chancery Courts) to have authority over him. Chancery Courts are tribunal courts where the decisions of "justice" are decided by 3 "judges". This is a direct result of the Crown Temple having invoked their Rule and Code over all judicial courts.

"It is held to be a settled Rule, that our courts can not take notice of any title to land not derived from the State or Colonial government, and duly verified by patent." -4 *Johns. Rep.* 163. Jackson v. Waters, 12 *Johns. Rep.* 365. S.P.

The Crown Temple was granted **Letters Patent** (see definition above) and **Charters** (definition below) for all the land (Colonies) of New England by the King of England, a sworn member of the Middle Temple (as the Queen is now). Since the people were giving the patent/charter corporations and Colonial Governours such a hard time, especially concerning Crown taxation, a scheme was devised to allow the Americans to believe they were being granted "independence." Remember, the Crown Templars represented both parties to the 1776 Declaration of Independence; and, as we are about to see, the latter 1787 U.S. Constitution.

To have this "Declaration" recognized by international treaty law, and in order to establish the new legal Crown entity of the incorporated **United States**, Middle Templar King George III agreed to the <u>Treaty of Paris</u> on September 3, 1783, "between the Crown of Great Britain and the said **United States**". The Crown of Great Britain legally was, then and now, the Crown Temple. This formally gave international recognition to the corporate "United <u>States</u>", the new Crown Temple States (Colonies). Most important is to know who the actual signatories to the *Treaty of Paris* were. Take particular note to the abbreviation "Esqr." following their names (see above definition for ESQUIRE) as this legally signifies "Officers of the King's Courts", which we now know were Templar Courts or Crown Courts. This is the same Crown Templar Title given to Alexander Hamilton (see above).

The Crown was represented in signature by "David Hartley, Esqr.", a **Middle Templar of the King's Court**. Representing the United States (a Crown franchise) by signature was "John Adams, Esqr", "Benjamin Franklin, Esqr." and "John Jay, Esqr." The signatories for the "United States" were also **Middle Templars of the King's Court** through Bar Association membership. What is plainly written in history proves, once again, that **the Crown Temple was representing both parties to the agreement**. What a perfect and elaborate scam the people of North America had pulled on them!

It becomes even more obvious when you read Article 5, which states in part,

"to provide for the Restitution of all Estates, Rights, and Properties which have been confiscated, belonging to real British Subjects."

The Crown Colonies were granted to "persons" and corporations of the Crown Temple through Letters Patent and Charters, and the North American Colonial land was owned by the Crown. Since 1883, the Crown has been receiving "restitution" from the United States, their incorporated Crown franchisee, because the Crown owns the land through paramount and allodial title as a possessory estate.

Now, here's a real catch-all in *Article 4*:

"It is agreed that creditors on either side shall meet with no lawful impediment to the recovery of the full value in sterling money of all bona fide debts heretofore contracted."

Since the Crown and its Templars represented both the United States, as the debtors, and the Crown, as the creditors, then they became the creditor of the American people by owning all debts of the former Colonies, now called the legal Crown States. This sounds too good to be

true, but these are the facts. The words SCAM and HOODWINKED can't begin to describe what had taken place.

So then, what debts were owed to the Crown Temple and their banks as of 1883? In the **Contract Between the King and the Thirteen United States of North America**, signed at Versailles July 16, 1782, **Article I** states,

"It is agreed and certified that the sums advanced by His Majesty to the Congress of the United States under the title of a loan, in the years 1778, 1779, 1780, 1781, and the present 1782, amount to the sum of <u>eighteen million</u> of livres, money of France, according to the following twenty-one receipts of the above-mentioned underwritten Minister of Congress, given in virtue of his full powers, to wit..."

That amount equals about \$18 million dollars, plus interest, that Hamilton's U.S. Central Bank owed the Crown through Crown Bank loans in France. This was signed, on behalf of the United States, by an already familiar Middle Templar, **Benjamin Franklin**, **Esquire**.

An <u>additional \$6 million dollars</u> (six million livres) was loaned to the United States at <u>5% interest</u> by the same parties in a similar <u>Contract</u> signed on February 25, 1783. The Crown Bankers in the Netherlands and France were calling in their debts for payment by future generations of Americans.

The Fiscal Agents of Mystery Babylon

Since its beginnings, the Temple Church at the City of London has been a Knight Templar secret society. It was built and established by the same Temple Knights who were given their Rule and Order by the Roman Pope. It's very important to know how the British Royal Crown was placed into the hands of the Knights Templars, and how the Crown Templars became the fiscal and military agents for the Pope of the Roman Church.

This all becomes very clear through the <u>Concession Of England To The Pope</u> on May 15, 1213. This **charter** was sworn in **fealty** by England's King John to Pope Innocent and the Roman Church. It was witnessed before the Crown Templars, as King John stated upon sealing the same,

"I myself bearing witness in the house of the Knights Templars."

Pay particular attention to the words being used that we have defined below, especially <u>charter</u>, <u>fealty</u>, <u>demur</u>, and <u>concession</u>:

We wish it to be known to all of you, through this our charter, furnished with our seal... not induced by force or compelled by fear, but of our own good and spontaneous will and by the common counsel of our barons, do offer and freely concede to God and His holy apostles Peter and Paul and to our mother the holy Roman church, and to our lord pope Innocent and to his Catholic successors, the whole kingdom of England and the whole kingdom Ireland, with all their rights and appurtenances... we perform and swear fealty for them to him our aforesaid lord pope Innocent, and his catholic successors and the Roman church... binding our successors and our heirs by our wife forever, in similar manner to perform fealty and show homage to him who shall be chief pontiff at that time, and to the Roman church without demur. As a sign... we will and establish perpetual obligation and concession... from the proper and especial revenues of our aforesaid kingdoms... the Roman church shall receive yearly a thousand marks sterling... saving to us and to our heirs our rights, liberties and regalia; all of which things, as they have been described above, we wish to have perpetually valid and firm; and we bind ourselves and our successors not to act counter to them. And if we or any one of our successors shall presume to attempt this, whoever he be, unless being duly warned he come to his kingdom, and this senses, be shall lose his right to the kingdom, and this charter of our obligation and concession shall always remain firm.

Most who have commented on this charter only emphasize the payments due the Pope and the Roman Church. What should be emphasized is the fact that King John broke the terms of this charter by signing the Magna Carta on June 15, 1215. Remember; the penalty for breaking the 1213 agreement was the loss of the Crown (right to the kingdom) to the Pope and his Roman Church. It says so quite plainly. To formally and lawfully take the Crown from the royal monarchs of England by an act of declaration, on August 24, 1215, Pope Innocent III annulled the Magna Carta; later in the year, he placed an Interdict (prohibition) on the entire British empire. From that time until today, the English monarchy and the entire British Crown belonged to the Pope.

The following definitions are all taken from *Webster's 1828 Dictionary* since the meanings have not been perverted for nearly 200 years:

FEALTY, n. [L. *fidelis*.] Fidelity to a lord; faithful adherence of a tenant or <u>vassal to the superior</u> of whom he holds his lands; loyalty. Under the feudal system of tenures, every vassal or tenant was bound to be true and faithful to his lord, and to defend him against all his enemies. This obligation was called his fidelity or fealty, and <u>an oath of fealty was required to be taken by all tenants to their landlords</u>. The tenant was called a liege man; <u>the land, a liege fee</u>; and the superior, liege lord.

FEE, n. [In English, is <u>loan</u>. This word, fee, inland, or an <u>estate in trust</u>, originated among the descendants of the northern conquerors of Italy, but it originated in the south of Europe. See Feud.] Primarily, <u>a loan of land</u>, an estate in trust, granted by a prince or lord, to be held by the <u>grantee</u> on condition of personal service, or other condition; and <u>if the grantee</u> or tenant failed to perform the conditions, the land reverted to the lord or donor, called the <u>landlord</u>, or lend-lord, the lord of the loan. A fee then is any land or tenement held of a superior on certain conditions. It is synonymous with fief and feud. <u>In the United States</u>, an estate in fee or fee simple is what is <u>called in English law an allodial estate</u>, an estate held by a person in his own right, and <u>descendible to the heirs</u> in general.

FEUD, n. [L. fides; Eng. <u>loan</u>.] A fief; a fee; <u>a right to lands</u> or hereditaments held in <u>trust</u>, or on the terms of performing certain conditions; the right which a vassal or tenant has to the lands or other immovable thing of his lord, to use the same and <u>take the profits thereof hereditarily</u>, rendering to his superior such duties and services as belong to military tenure, &c., <u>the property of the soil always remaining in the lord or superior</u>.

By swearing to the 1213 Charter in fealty, King John declared that the British-English Crown and its possessions at that time, including all <u>future</u> possessions, estates, trusts, charters, letters patent, and land, were <u>forever</u> bound to the Pope and the Roman Church, the **landlord**. Some five hundred years later, the New England Colonies in America became a part of the Crown as a possession and trust named the "United States."

ATTORNING, ppr. Acknowledging a new lord, or transferring homage and fealty to the purchaser of an estate.

Bar Attorneys have been attorning ever since they were founded at the Temple Church, by acknowledging that the Crown and he who holds the Crown is the new lord of the land. Because King John defaulted on the 1213 contract, the new Crown (the Crown Temple) had a new lord: The Pope and his Roman Church.

CHARTER, n. 1. A written instrument, executed with usual forms, given as evidence of a grant, contract, or whatever is done between man and man. In its more usual sense, it is the instrument of a grant conferring powers, rights and privileges, either from a king or other sovereign power, or from a private person, as a charter of exemption, that no person shall be empanelled on a jury, a charter of pardon, &c. The charters under which most of the colonies in America were settled, were given by the king of England, and

incorporated certain persons, with **powers to hold the lands granted**, to establish a government, and **make laws for their own regulation**. These were **called charter-governments**.

By agreeing to the Magna Carta, King John had broken the agreement terms of his fealty with Rome and the Pope. What that means is that he lost all rights to the kingdom, and the royal English Crown was turned over by default to the Pope and the Roman Church.

The Pope and his Roman Church control the Crown Temple because his Knights established it under his Orders. So also the Temple Banks, the Templar Attorneys, the corporate United States, the corporate British Commonwealth, the chartered Federal Reserve Bank and Bank of England; the list is nearly endless. He who controls the gold controls the world.

The Crown Temple Today

The workings of the Crown Temple in this day and age is moreso obvious, yet somewhat hidden. The Crown Templars have many names and many symbols to signify their private and unholy Temple. Take a close look at the (alleged) one dollar \$1 private Federal Reserve System (a Crown banking franchise) Debt Note.

Notice in the base of the pyramid the Roman date MDCCLXXVI which is written in Roman numerals for the year 1776. The words ANNUIT COEPTIS NOVUS ORDO SECLORUM are Roman Latin for ANNOUNCING THE BIRTH OF THE NEW ORDER OF THE WORLD. Go back to the definitions above and pay particular attention to the words CAPITOL, CROWN and TEMPLE. 1776 signifies the birth of the New World Order under the Crown Temple.



That's when their American Crown Colonies became the chartered government called the United States, thanks to the Declaration of Independence. Since that date, the United Nations (another legal Crown Temple by charter) rose up and refers to every nation as a <u>State member</u>. Note also that there are 13 layers for the pyramid denoting the 13 chartered Colony-States and that the eye of Osirus, one of many Templar signs used the Temple Illuminati or their Order of the Rose and Order of the Cross.

The Wizard of Oz = the Crown Temple

This is not a mere child's story written by L. Frank Baum. What symbol does "Oz" stand for? Ounces. What is measured in ounces? Gold. What is the yellow brick road? Bricks or ingot bars of gold.

The character known as the **Straw Man** represents that fictitious <u>ALL CAPS</u> legal fiction - a <u>PERSON</u> - the Federal U.S. Government created with the same spelling as your Christian birth name. Remember what the Straw Man wanted from the Wizard of Oz? A brain! No legal fiction has a brain because they have no breath of life! What did he get in place of a brain? A Certificate. A <u>Birth Certificate</u> for a new legal creation. He was proud of his new legal status, plus all the other legalisms he was granted. Now he becomes the true epitome of the brainless sack of straw who was given a Certificate in place of a brain of common sense.

What about the **Tin Man**? Does **T**axpayer **I**dentification **N**umber (TIN) mean anything to you? The poor TIN Man just stood there mindlessly doing his work until his body literally froze up and stopped functioning. He worked himself to death because he had no heart nor soul. He's the heartless and emotionless creature robotically carrying out his daily task as if he was already dead. He's the ox pulling the plow and the mule toiling under the yoke. These days, his task masters just oil him nightly with beer and place him in front of a hypnotic television until his very existence no longer has any meaning or value. His masters keep him cold on the outside and heartless on the inside in order to control any emotions or heart he may get a hold of.

The pitiful **Cowardly Lion** was always too frightened to stand up for himself. Of course, he was a bully and a big mouth when it came to picking on those smaller than he was. Did you ever notice how bullies are really the biggest cowards? They act as if they have great courage, but they really have none at all. All roar with no teeth of authority to back them up. He wanted courage from the Grand Wizard, so he was awarded a medal of "official" recognition. There is no mystery behind the current abomination of Babylon for those who discern His Truth:

And upon her forehead was a name written, MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH. - Revelation 17:5

God has reserved His judgment for the great idolatress, Rome, the chief seat of all idolatry, that rules over many nations with whom the kings have committed to the worship of her idols (see *Revelation 17:1-4*). The Pope and His purported Church; sitting on the Temple throne at the Vatican; ruling the nations of the earth through the Crown Temple of ungodly deities are the Rule and Order of Babylon; the Crown of godlessness and the Code of commerce.

One may call the Rule of the world today by many names: The New World Order (a Bush family favourite), the Third Way (spoken by Tony Blair and Bill Clinton), the Illuminati, Triad, Triangle, Trinity, Masonry, the United Nations, the EU, the US, or many dozens of other names. However, they all point to one origin and one beginning. We have traced this in history to **the Crown Temple, the Temple Church circa 1200**. The 1611 King James (who was a Crown Templar) Bible is *not* the entire canon of the early church ("church" in *Latin* ecclesia; in *Greek* ekklesia). There were other gospels and books that have been forbidden by the Papal Throne at Rome since the third century. Greek and Aramaic copies of the "unapproved writings" were sought after and destroyed by Rome. This in itself is no mystery as history records the existence and destruction of these early church writings; just as history has now proven their genuine authenticity with the appearance of the Dead Sea Scrolls and the coptic library at Nag Hagmadi in Egypt, among many other recent Greek language discoveries within the past 100 years.

The current Holy Bible guotes the Book of Enoch numerous times:

By faith Enoch was taken away so that he did not see death, "and was not found, because God had taken him"; for before he was taken he had this testimony, that he pleased God. - Hebrews 11:5

Now Enoch, the seventh from Adam, prophesied about these men also, saying, "Behold, the Lord comes with ten thousands of His saints, to execute judgment on all, to convict all who are ungodly among them of all their ungodly deeds which they have committed in an ungodly way, and of all the harsh things which ungodly sinners have spoken against Him." - Jude 1:14-15

The Book of Enoch was considered scripture by most early Christians. The earliest literature of the so-called "Church Fathers" is filled with references to this mysterious book. The second century Epistle of Barnabus makes much use of the Book of Enoch. Second and Third Century "Church Fathers," such as Justin Martyr, Irenaeus, Origin and Clement of Alexandria, all make use of the Book of Enoch. Tertullian (160-230 C.E) even called the Book of Enoch "Holy Scripture". The Ethiopic Church included the Book of Enoch to its official canon. It was widely known and read the first three centuries after Christ. However, this and many other books became discredited after the Roman Council of Laodicea. Being under ban of the Roman Papal authorities, afterwards they gradually passed out of circulation.

At about the time of the Protestant Reformation, there was a renewed interest in the *Book of Enoch*, which had long since been lost to the modern world. By the late 1400's, rumors began to spread that a copy of the long lost *Book of Enoch* might still exist. During this time, many books arose claiming to be the lost book but were later found to be forgeries.

The return of the *Book of Enoch* to the modern western world is credited to the famous explorer James Bruce, who in 1773 returned from six years in Abyssinia with three Ethiopic copies of the lost book. In 1821, Richard Laurence published the first English translation. The now famous R.H. Charles edition was first published by Oxford Press in 1912. In the following years, several portions of the Greek text also surfaced. Then, with the discovery of cave number four of the Dead Sea Scrolls, seven fragmentary copies of the Aramaic text were discovered.

Within the **Book of Enoch** is revealed one of the mysteries of Babylon concerning the seven mountains she sits upon (underlining has been added):

[CHAPTER 52] ² There mine eyes saw all the secret things of heaven that shall be; a mountain of iron, a mountain of copper, a mountain of silver, a mountain of gold, a mountain of soft metal, and a mountain of lead.

6 These [6] mountains which thine eyes have seen: The mountain of iron, the mountain of copper, the mountain of silver, the mountain of gold, the mountain of soft metal, and the mountain of lead. All these shall be in the presence of the Elect One as wax: Before the fire, like the water which streams down from above upon those mountains, and they shall become powerless before his feet. 7 It shall come to pass in those days that none shall be saved, either by gold or by silver, and none be able to escape. 8 There shall be no iron for war, nor shall one clothe oneself with a

breastplate. <u>Bronze shall be of no service</u>, <u>tin shall be of no service</u> and shall not be esteemed, and <u>lead shall not be desired</u>. 9 All these things <u>shall be denied and destroyed from the surface of the earth</u> when the Elect One shall appear before the face of the Lord of Spirits.'

[CHAPTER 24] 3 The <u>seventh mountain</u> was in the midst of these, and it excelled them in height, resembling the seat of a throne; and fragrant trees encircled the throne.

[CHAPTER 25] 3 And he answered saying: 'This high mountain which thou hast seen, whose summit is like the throne of God, is His throne, where the Holy Great One, the Lord of Glory, the Eternal King, will sit, when He shall come down to visit the earth with goodness. 4 As for this fragrant tree, no mortal is permitted to touch it until the great judgement when He shall take vengeance on all and bring (everything) to its consummation for ever. 5 It shall then be given to the righteous and Holy. Its fruit shall be for food to the elect: It shall be transplanted to the Holy place, to the temple of the Lord, the Eternal King. 6 Then shall they rejoice with joy and be glad, and into the Holy place shall they enter; its fragrance shall be in their bones and they shall live a long life on earth, such as thy fathers lived: In their days shall no sorrow, or plague, or torment, or calamity touch them.'

The present wealth and power of all the world's gold, silver, tin, bronze, pearls, diamonds, gemstones, iron, and copper belonging the Babylon whore, and held in the treasuries of her Crown Templar banks and deep stony vaults, will not be able to save them at the time of the Lord's judgment.

But woe unto you, scribes and Pharisees, hypocrites! for ye shut up the kingdom of heaven against men: for ye neither go in [yourselves], neither suffer ye them that are entering to go in. – Matthew 23:13

Where do we go from here?

Now that their false Temple has been exposed, how does this apply to the Kingdom of Heaven? To reach the end, you must know the beginning. 

China reportedly <u>supported</u> Tedros's rise to lead the WHO in 2017, even though he was not trained as a medical doctor.

The WHO Director is a Member of the Leftist Tigrayan People's Liberation Front (TPLF)

As a <u>member</u> of the violent and powerful communist Ethiopian political party known as the Tigrayan People's Liberation Front (<u>TPLF</u>), Tedros <u>rose</u> through Ethiopia's autocratic regime as health (2005-2012) and foreign minister (2012-

Ethiopia has borrowed billions from <u>China</u>, reportedly including more than <u>\$13 billion</u> during Tedros' tenure as foreign minister between 2012 and 2016.

We note China's connections to Tedros's homeland of Ethiopia, now called East Africa's 'Little China'

because it has become <u>China's bridgehead</u> to influence Africa and a key to China's <u>Belt and Road initiative there</u>. Indeed, China has <u>invested</u> heavily in Ethiopia.




Citing the coronavirus threat last month, Ethiopian Prime Minister Abiy Ahmed issued <u>asked</u> the international community for immediate debt relief. China has become Ethiopia's <u>largest</u> trading partner, thanks in part to Beijing's' investments in the African country while Tedros was foreign minister.

Tedros named Robert Mugabe a WHO 'goodwill ambassador'

In October 2017, Tedros named Mugabe a "goodwill ambassador" to help combat non-communicable diseases in Africa, provoking <u>outrage</u> from medical professionals and human rights groups. At the time the *New York Times* noted:

The role of good-will ambassador is largely symbolic, but rights groups were scathing in their reaction to the symbolism of giving it to a man whose leadership, they say, has led to the collapse of its health service and major rights abuses in Zimbabwe.

Ultimately, Tedros <u>rescinded</u> his decision to name Mugabe "goodwill ambassador" in the wake of criticism.

This is how the virus was created.

Intervirion Fusion. HIV-luc(ACE2) (500 ng of p24) was mixed with 1,000 ng of p24 of HIV-gfp particles incorporating ASLV-A envelope, SARS-CoV S protein, or both envelopes in PBS at 4°C for 30 min to allow binding. Samples were raised to 37°C for 15 min to allow for conformational rearrangements. Virions were adjusted to the desired pH with 0.1 M citric acid. PBS, TPCK-trypsin (final concentration 10 μ g/ml), CTSL, cathepsin B (CTSB) (final concentrations 2 μ g/ml) or CTSL buffer alone was then added. Recombinant CTSL (R &D Systems) was preactivated by incubation for 15 min at 10 μ g/ml in 50 mM Mes, pH 6.0, on ice. Recombinant CTSB (R &D Systems) was preactivated in 25 mM Mes, 5 mM DTT, pH 5.0, for 30 min at 25°C. After a 10-min incubation at 25°C, proteolysis was halted by the addition of 300 μ l of DMEM10 containing leupeptin (25 μ g/ml) and STI (75 μ g/ml). Virions were then incubated at 37°C for 30 min to allow membrane fusion. 100 μ l of the virion mixture was added in quadruplicate to HeLa-Tva cells pretreated for 1 h with leupeptin (20 μ g/ml). The cells were spin-infected and incubated at 37°C for 5 h
