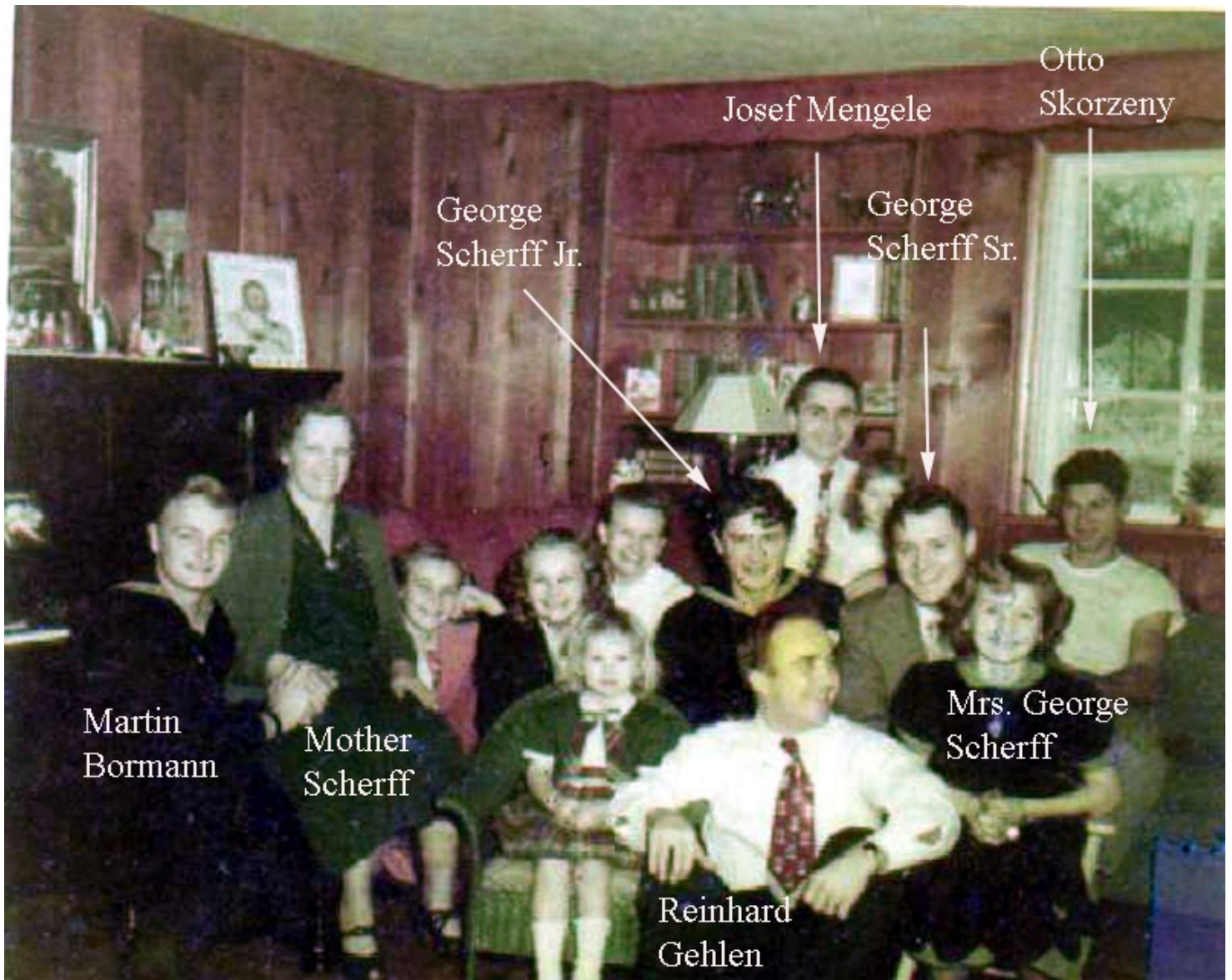

 January 28, 1797	Obadiah Newcomb Bush was born in Penfield, New York, USA. Obadiah was the husband of Harriet Smith and the Father of James Smith Bush.
 1821	Obadiah marries Harriet Smith.
 June 15, 1825	James Smith Bush was born, was the husband of Sarah Freeman, then Harriet Eleanor, and the father of Samuel Prescott Bush.
1828	Obadiah Bush was a schoolmaster in New York.
1849	Obadiah Bush traveled to California with the forty-niners during the gold rush.
 February 9, 1851	Obadiah Bush, seeking to relocate there permanently, set out for the East Coast by sea to wrap up his affairs and retrieve his family but died en route and was buried at sea.
 1851	Sarah Freeman married James Smith Bush, but she died 18 months later during childbirth.
 February 24, 1859	Harriet Eleanor [Fay] was the wife of James Smith Bush and the mother of Samuel Prescott Bush.
 October 4, 1863	Samuel Prescott Bush was born. Samuel was the husband of Flora Sheldon and the father of Prescott Sheldon Bush.
 August 15, 1868	James Robinson was born. James was the husband of Lula Flickinger and the father of Pauline Robinson.
 March 17, 1872	Flora Sheldon was born. Flora was the Wife of Samuel Prescott Bush and the mother of Prescott Sheldon Bush.
 September 17, 1874	Loulie Wear was born. Loulie was the wife of George Herbert Walker and the mother of Dorothy Walker.
 May 1875	Lula Flickinger was born. Lula was the wife of James Robinson and the mother to Pauline Robinson.
 June 11, 1875	George Herbert Walker was born. George was the husband of Loulie Wear and the Father of Dorothy Walker.
 April 20, 1889	Adolf Hitler was born in Braunau am Inn, Austria-Hungary (now Austria).

	June 17, 1893	Marvin Pierce was born. Marvin was the husband of Pauline Robinson and father of Barbara Pierce Bush.
	May 15, 1895	Prescott Sheldon Bush was born. Prescott was the husband of Dorothy Walker and the father of George H.W. Bush.
	April 1896	Pauline Robinson was born. Pauline was the wife of Marvin Pierce and mother of Barbara Pierce Bush.
	July 1, 1901	Dorothy Walker was born. Dorothy was the wife of Prescott Sheldon Bush and the mother to George H.W. Bush.
	1901	George Herbert Walker joined the banking and investment firm Brown Brothers in New York City.
	1901	Samuel Prescott Bush became general manager of Buckeye Steel Castings Company, which manufactured railway parts. The company was run by Frank Rockefeller, the brother of oil magnate John D. Rockefeller, and among its clients were the railroads controlled by E. H. Harriman.
	1908	George Herbert Walker became a partner at Brown Brothers, which later merged with Harriman & Co. to form Brown Brothers Harriman (BBH).
	????	Samuel Prescott Bush served on the board of the Federal Reserve Bank of Cleveland (as well as of the Huntington National Bank of Columbus).
	1914-1918	Hitler served as a soldier in the German Army during World War I.
	1917-1918	Prescott Sheldon Bush served as an artillery officer in the U.S. Army during World War I.
	1919	Hitler joins the German Workers' Party (DAP), a precursor to the Nazi Party.
	1920	The DAP is renamed the National Socialist German Workers' Party (NSDAP), or Nazi Party, with Hitler as a key member.
	1922	George Herbert Walker and W. Averell Harriman traveled to Berlin to set up a German branch of their banking and investment operations, which were largely based on critical war resources such as steel and coal. Walker and Harriman also partnered with another German titan, Friedrich Flick, who partnered with Thyssen in the German Steel Trust that forged the Nazi war machine.
	1923	Hitler's failed Beer Hall Putsch in Munich was a failed coup d'état by Nazi Party (NSDAP) leader Adolf Hitler, resulting in his arrest and imprisonment on charges of treason. The putsch brought Hitler to the attention of the German nation for the first time and generated front-page headlines in newspapers around the world. His arrest was followed by a 24-day trial, which was widely publicized and gave him a platform to express his nationalist sentiments to the nation. Hitler was found guilty of treason and sentenced to five years in Landsberg Prison.
	1924	While in prison, Hitler wrote "Mein Kampf," outlining his political ideology and vision for Germany.
	1924	Prescott Sheldon Bush joins the investment banking firm Brown Brothers Harriman (BBH) and becomes a partner.
	1924	Union Banking Corporation (UBC) of New York was formed by Averell Harriman on behalf of Thyssen and his bank, voor Handel en Scheepvaart N.V. of Holland. UBC was a clearing house for a number of Tyssen-controlled enterprises and assets, including a dozen individual businesses. UBC also bought and shipped overseas gold, steel, coal, and U.S. Treasury bonds. The company's activities were administered for Tyssen by a Netherlands-born, naturalized U.S. citizen named Cornelis Lievens, who served as president of UBC. Roland Harriman was chairman and Prescott Bush a managing director.
	June 12, 1924	George H. W. Bush was born. George was the husband of Barbara Pierce Bush and the father of George W. Bush, Robin Bush, John Ellis "Jeb" Bush, Neil Mallon Bush, Marvin Pierce Bush, and Doro Bush.
	June 8, 1925	Barbara Pierce was born. Barbara was the wife of George H. W. Bush and the mother of George W. Bush, Robin Bush, John Ellis "Jeb" Bush, Neil Mallon Bush, Marvin Pierce Bush, and Doro Bush. It is rumored that Barbara's mom Pauline had an affair with Alexander Crowley, British occultist, writer, and mountaineer, who was a practitioner of "magic" (as he spelled it) and called himself

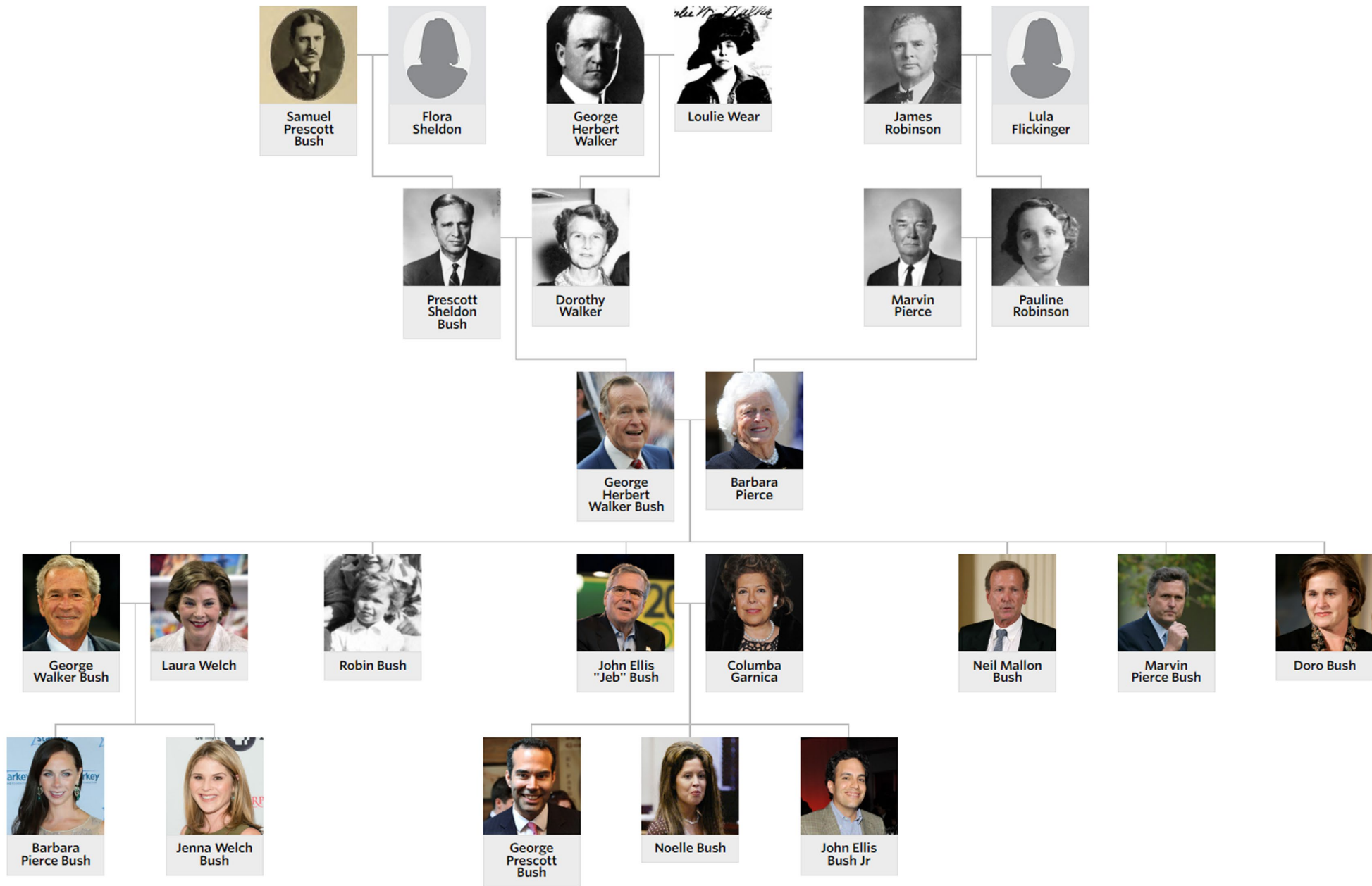
		the Beast 666. The theory is that Barbara is his daughter. While the resemblance is striking, there is no known evidence.
	1926	Prescott Bush married Dorothy Walker, daughter of George Herbert Walker.
	1927	George Herbert Walker served as the president of W.A. Harriman & Co. Walker brought on Prescott as vice president.
	1931	George Herbert Walker became chairman of the board at W.A. Harriman & Co.
	1931	Prescott Sheldon Bush became a vice president at BBH.
	1932	The Glass-Steagall Act was passed which separates commercial and investment banking, leading BBH to focus more on investment banking.
	January 30, 1933	Hitler became Chancellor of Germany, using his position to consolidate power and eliminate political opposition.
	February 15, 1933	Assassination attempt on Franklin Delano Roosevelt. A deranged bricklayer named Guisepppe Zangara fired five bullets at FDR from close range. A bystander deflected his hand, but Zangara wounded four people and killed Chicago Mayor Anton Cermak.
	March 4, 1933	Franklin Delano Roosevelt took office.
	March 9, 1933	The Emergency Banking Act was signed into law.
	March 12-13, 1933	President Roosevelt's administration began implementing the New Deal, a series of economic programs aimed at providing relief, recovery, and reform.
	1933	"Business Plot" or the "1933 Business Plot". Wall Street millionaires and retired military figures literally plotted to overthrow President Roosevelt from office.
	December 5, 1933	The 21st Amendment was ratified, ending Prohibition, and legalizing the sale of alcohol.
	1939	Germany invaded Poland, sparking World War II. Britain and France declared war on Germany.
	1939-1942	George Herbert Walker & the German War Machine. George W. Bush's great-grandfather was a Wall Street banker and director or president of G.H. Walker and Co., JP Morgan and Co., Guaranty Trust Co., W.A. Harriman and Co., and Union Banking Corporation. Walker made his fortune building up the Soviet Union and Nazi Germany, financing their oil, coal, steel, and manganese industries among others. As president of the Union Banking Corp. (UBC), he laundered money for Hitler and supplied raw materials essential for Germany's waging World War II. His most prominent partners in financing Hitler's war machine were Averell Harriman and Prescott Bush.
	1939-1942	Prescott Bush Third Reich financier extraordinaire Prescott Bush was a director and shareholder of companies that profited from their involvement with the financial backers of Nazi Germany. He worked with an American Bank that directly funded the Third Reich. It has been suggested that the money he made from these dealings helped to establish the Bush family fortune and set up its political dynasty. Together George Herbert Walker, Prescott Bush, and Averell Harriman ran Hamburg-Amerika Line (a cover for I.G. Farben's Nazi espionage unit in the U.S.), the American Ship and Commerce Co. (which smuggled German agents, propaganda, and money into America to bribe American politicians to support the Nazi cause), the Harriman Fifteen Corporation, and the Silesian Holding Company. In addition, their consolidated Silesian Steel Corporation owned 1/3 of a complex of steelmaking, coal mining, and zinc-mining activities in Germany. The other 2/3 was owned by Friederich Flick.
	December 7, 1941	Japan attacked Pearl Harbor, leading the U.S. to enter World War II.

	August 28, 1943	Under the Trading with the Enemies Act, U.S. Congress seized the first of the Bush-Harriman-managed Tyssen entities: Hamburg-American Line (See Vesting Order No. 126.) Holland-American Trading Corp. (See Vesting Order 261) Seamless Steel Equipment Corp. (See Vesting Order 259)
	October 20, 1942	U.S. Congress seized UBC and liquidated its assets after the war. (See Vesting Order No. 248) Silesian-American Corp. assets seized by the U.S. Government. Flick, Walker, Harriman, and Bush equipped the Nazi Army with stolen goods from Poland and fueled Soviet vehicles from Baku wells. This led to a civil action 60 years later for damages being brought in Germany against the Bush family by two former slave laborers at Auschwitz.
	1942-1945	During World War II, Prescott Bush served as director of the United Service Organizations (USO) in New England.
	June 6, 1944	D-Day, the Allied invasion of Normandy, France, marks a significant turning point in World War II.
	1945-1946	Nuremberg Trials Friederich Flick, the owner of 2/3 of the steelmaking, coal-making, and Zinc mining activities in Germany was sentenced to 7 years imprisonment by the Nuremberg Tribunal, however, his American Partners were never tried.
	1942 -1945	George H. Bush served in the Navy during World War II Bush's plane was shot down in a bombing run over the island of Chichi Jima, a key location for Japanese operations in the Pacific. In September 1944, nine American airmen survived when their planes were shot down off the coast of the tiny Pacific Island of Chichi Jima. Eight of the young men were captured by the Japanese, tortured, and eaten. The ninth drifted out to sea and was remarkably rescued by the US Navy. That survivor was a 20-year-old pilot who would go on to become President, George HW Bush. Alone in the ocean off the coast of Chichi Jima, Bush was eventually rescued by an American submarine on patrol for downed pilots. 	April 12, 1946	President Roosevelt died, and Vice President Harry S. Truman became the 33rd President.
	July 6, 1946	George W. Bush was born. George is the husband of Laura Welch and the father of Barbara Pierce Bush and Jenna Welch Bush.
	August 6 and 9, 1946	The U.S. dropped atomic bombs on the Japanese cities of Hiroshima and Nagasaki, leading to Japan's surrender on August 15.
	November 4, 1946	Laura Welch was born. Laura is the wife of George W. Bush and the father of Barbara Pierce Bush and Jenna Welch Bush.
	March 12, 1947	President Truman announced the Truman Doctrine, pledging U.S. support for countries resisting communism.
	September 18, 1947	The passage of the National Security Act of 1947 created the Central Intelligence Agency
	February 8, 1948	Samuel Prescott Bush dies.



Otto Skorzeny told Eric Bermen that George Scherff Jr, identified in the above photo, and George Herbert Walker Bush, the 41st President of the United States, are one and the same person. After reading Don Nicoloff's article, I was initially under the impression that George Scherff Sr. and Prescott Bush were two different men, but as I look at these photos, it seems to me that Prescott Sheldon Bush and George Scherff Sr. may be the same person. And I think it's beyond coincidence that the woman sitting in front of George Scherff Sr. in the above photo, looks astonishingly similar to Dorothy Wear Walker Bush (about 37 years old in this photo), who in 1949 is photographed standing in front of an airplane with her husband, Prescott S. Bush, and her son, George H.W. Bush (or is it George H. Scherff Jr.?).

Edward Henry Harriman was born. Edward was the husband of Mary Williams Averell and father of W. Averell Harriman.



Edward was born in Hempstead, New York. At age 14, he began working as an office boy in a New York brokerage house for a broker named Dewitt C. Hays. Harriman's uncle, Oliver Harriman, was a director of the Mutual Life Insurance Company, the Bank of America, and the New York Guaranty and Indemnity Co. When Harriman was 21 he borrowed \$3,000 from uncle Oliver to buy a seat on the Stock Exchange. In 1879 he married Mary Averill, daughter of the president of the Ogdensburg & Lake Champlain Railroad. In 1881, Harriman bought control of the Sodus Bay and Southern Railroad, and after making improvements, sold it to the Pennsylvania Railroad. His next purchase was for the Illinois Central Railroad.

Samuel Prescott Bush was born. Samuel was the husband of Flora Sheldon and the father of Prescott Sheldon Bush.

Samuel grew up in New Jersey, Staten Island, and San Francisco but spent the majority of his life in Columbus, Ohio. He graduated from the Stevens Institute of Technology in 1884. He started in an apprenticeship with the Pittsburg, Cincinnati, Chicago, and St. Louis Railroad, and by 1888, he became the assistant manager of railroad operations at the company's Dennison Shop and in 1894, superintendent of all its Columbia lines. In 1901, Samuel was hired as vice president and general manager of Buckeye Steel Castings which was owned by Frank Rockefeller. Seven years later, Samuel became President and general manager with an annual net income of \$350,000 on sales exceeding \$2.3 million. By 1917, his income reached \$1 million.

The Scottish-bred Walkers arrived in New England before the American Revolution. George had become wealthy beyond measure by 1917. His investment firm G.H. Walker and Company, which he founded in 1900 had become one of the more important investment firms in the Mississippi Valley. Walker got in on the ground floor of investment banking. He used his links to midwestern industry to become an advisor to J.P. Morgan & Company, banker E.H. Harriman, and St. Louis businessman Robert Brookings, founder of the conservative think tank, the Brookings Institute.

Prescott Sheldon Bush was born in Columbus, Ohio, and was an American banker and Republican Party politician. After working as a Wall Street executive investment banker, he represented Connecticut in the United States Senate from 1952 to 1963. A member of the Bush family, he was the father of President George H. W. Bush and the paternal grandfather of President George W. Bush and Florida Governor Jeb Bush. Prescott Bush was admitted to the Zeta Psi fraternity and Skull and Bones secret society and was among a group of Bonesmen who dug up and removed the skull of Geronimo from his grave at Fort Sill, Oklahoma, in 1918.

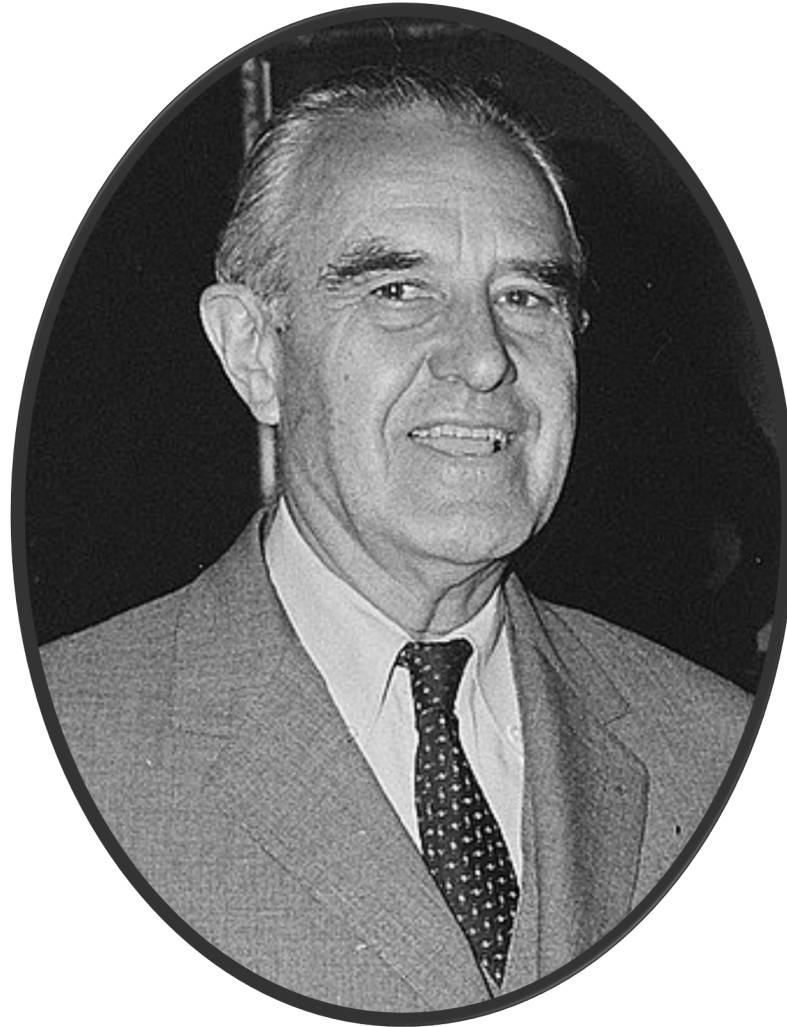

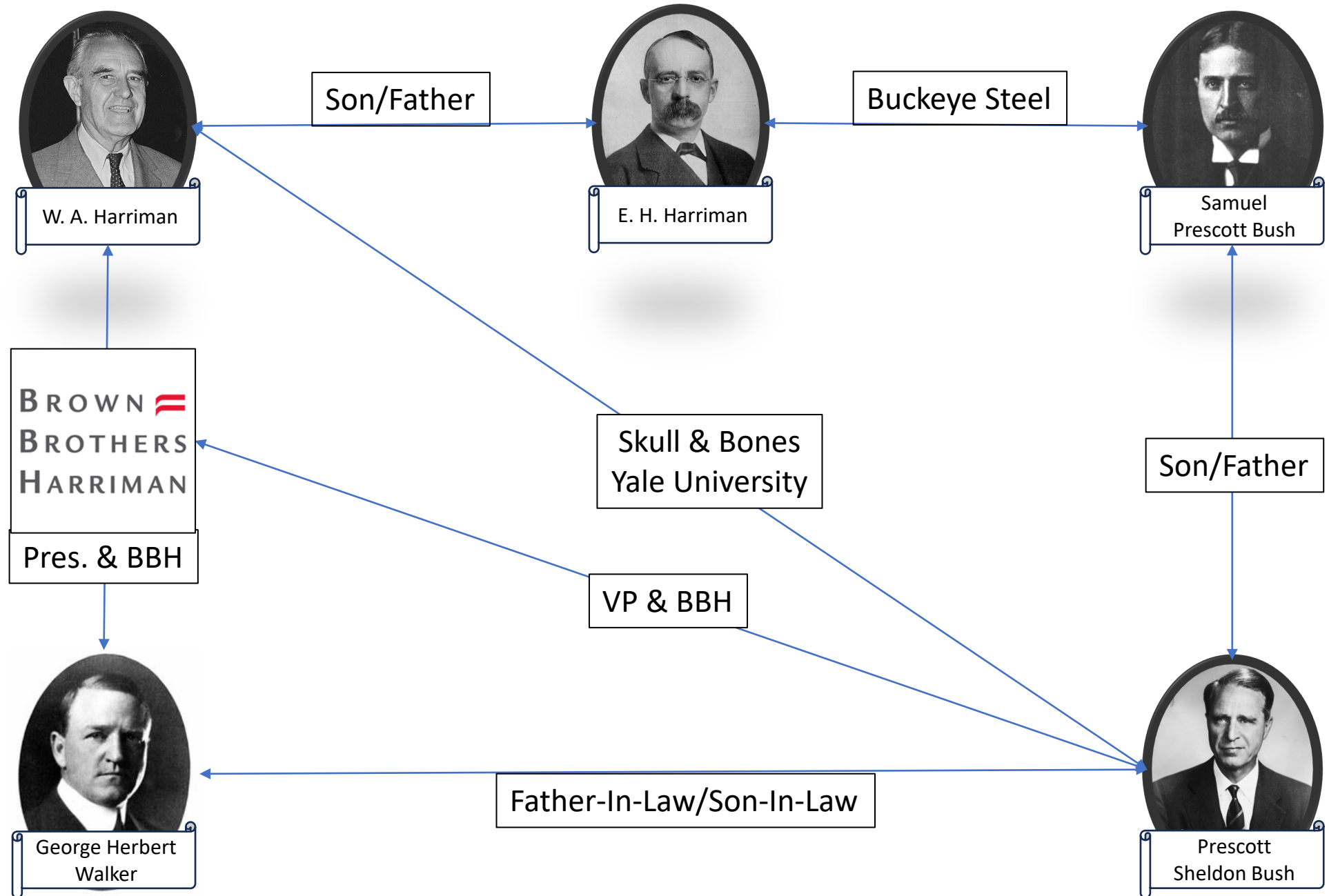


William Averell Harriman better known as Averell Harriman, was an American Democratic politician, businessman, and diplomat. The son of railroad baron E. H. Harriman, he served as Secretary of Commerce under President Harry S. Truman, and later as the 48th governor of New York. He was a candidate for the Democratic presidential nomination in 1952 and 1956, as well as a core member of the group of foreign policy elders known as "The Wise Men".

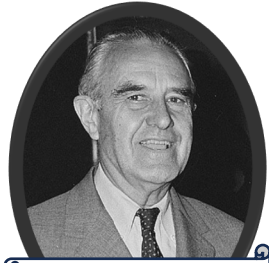

Throughout the 1920s, the New York and London investment banks participated with German backers of the Nazi Party, such as Fritz Thyssen, in increasing global cartels in steel, raw materials, and chemicals. The nazis were the operatives chosen to implement the banker's policies in Depression-wracked Germany. With plans to seize power in the United States, Britain, and France, along with the Nazis in Germany and Mussolini's Fascists in Italy, the aim of these private banking circles was world power.

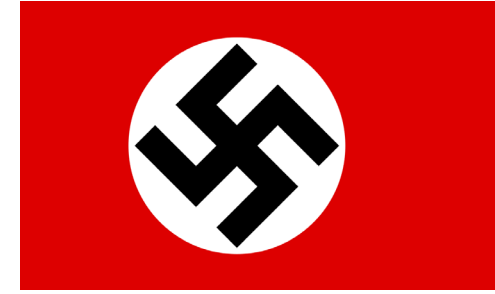
In 1932, as the U.S. Presidential campaign moved toward its conclusion, Hitler's Nazis were on the edge of financial ruin. A rescue effort was organized, with the supervision of the Bank of England's Montagu Norman, to funnel cash into the Nazi coffers. The principal Wall Street bank chosen to handle this operation was Brown Brothers Harriman whose principles included erstwhile playboy H. Averell Harriman, who was later to gain an important hold on the "liberal" wing of the Democratic Party, and Prescott Bush, grandfather of George W. Bush; Prescott Bush served as the bagman taking the funds to Germany. The plot was thwarted by Major General Smedley Butler.

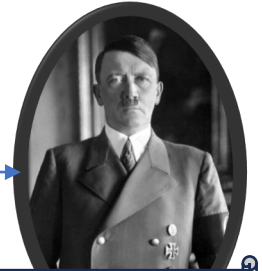

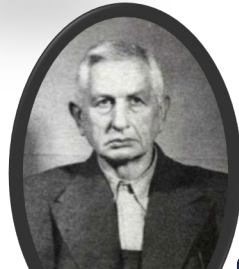

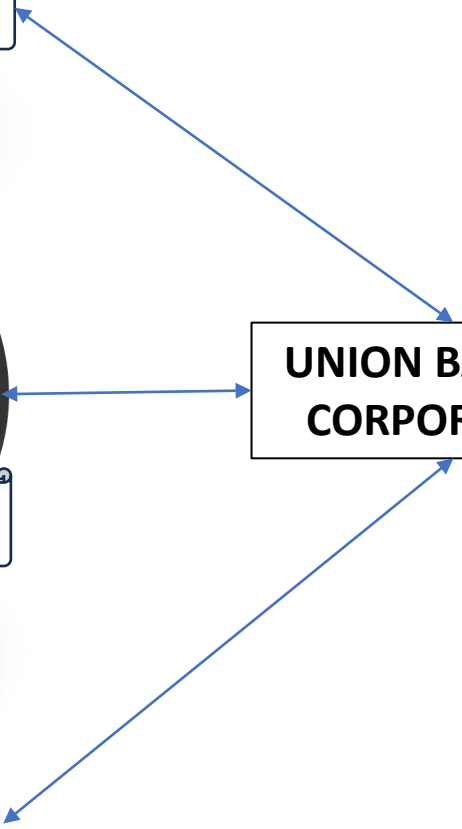

Former Federal Prosecutor John Loftus confirms the Bush-Nazi scandal

Some of our most famous American families, including the Bushes, made their fortunes from the Holocaust. Before I tell this awful story, I have to admit that I am a Democrat, but I quite like this President. He is not the sharpest tool in the shed, but he has a good heart, and the good sense not to follow in his father's footsteps. "W" has some good people around him who keep a firewall in the White House against his father's oil cronies. In terms of Republican politics, "W" is a rebel.

Morally, George W. Bush is the polar opposite of his grandfather and great grandfather (the "W" stands for Walker) who caused such havoc in the world with their Nazi investments. One cannot blame "W" for what his grandfather did, anymore than one can blame Jack Kennedy because his father bought Nazi stocks. What most people do not know is that Joseph Kennedy bought his Nazi stocks from Prescott Bush. Every great family has its scandal. The Bush family's scandal is that they funded Hitler and profited from the Holocaust.

It is quite possible that "W" (and his boyhood friend William Stamps Farrish, now US Ambassador to Britain) have tilted towards Israel perhaps because they wished to atone for the sins of their fathers. (Farrish's father committed suicide over his father's connections to the Bush-Nazi scandal.) Whatever the reason for the rebellion of the grandchildren, this Bush is quite a different man than his forbears. I like him and wish him well. But liking this Bush does not excuse my duty as a historian to tell the truth and let the chips fall where they may.

There was a great deal of skepticism ten years ago when I first wrote about the Bush-Nazi scandal in my book, "The Secret War Against the Jews." Its historical validity has now been confirmed by the ground breaking work of reporter John Buchanan. In October 2003, Buchanan unearthed the recently released Bush-Thyssen files in the US National Archives.

These long buried US government files demonstrate that the Bush family stayed on the corporate boards of Nazi front groups even after they knew beyond a shadow of a doubt that they were helping the financial cause of the Third Reich. It was all about the money. Nazi Germany is where the Bush family fortune came from, and where the Harrimans, and the Rockefellers increased their fortunes to obscene proportions.

Of course some of them were quite rich to begin with. The Harriman railroad monopoly helped create the Rockefeller oil monopoly in the 1800's. Their despicable price fixing schemes earned them the press label "the Robber Barons." My favorite Republican Teddy Roosevelt ruined their rapacious profits with his anti-monopoly and anti-trust legislation.

The Robber Barons bribed Congress (it happens) into passing a loophole, the Web-Pomerene Act of 1918 which legalized cartels and monopolies outside the borders of the United States. This loophole law let the Robber Barons loose to prey on a helpless world already ravaged by the human and financial cost of WWI.

Averil Harriman (patriarch of the famous Democratic family) promptly broke another American law by secretly financing the Bolsheviks while American, British and White Russian troops were still fighting against the infant communist revolution. (The FBI "ARCOS" files on Harriman's connections with the Soviets are quite a read). Harriman bribed Lenin into letting him take over the Czar's cartels, which exported managanese,

iron ore and other raw materials. Harriman shipped the Russian raw materials to his German partners, the Thyssens, who had been secretly bought out by the Rockefellers.

The Rockefeller' s lawyers, the Dulles Brothers, had deliberately and systematically bankrupted the German economy with the Versaille Treaty. German currency was almost worthless after WWI, and so the Dulles brother' s favorite clients, the Rockefellers, were able to buy the stock of nearly every German company for a song. The great sucking sound that preceeded the Great Depression was the whistling of Wall Street money out of America into Germany, Russia (and as a side deal, Saudi Arabia). Two generations later, we are still paying for it.

The Robber Barons did not call it an international crime. They called it synergy. Harriman' s Soviet cartels would deliver the raw materials, Rockfeller' s high tech German companies (the Thyssens) would process the manganese into steel for Harriman' s railroads. To save transportation costs, the Robber Barons looked for a middle ground in eastern Poland for a future factory site. It had to be in the coal fields of Silesia, on the banks of the Vistula river, where a canal could be dug to ship materials in cheaply from Russia. The Polish town was named Oswieczim, later known to the world by its German name: Auschwitz.

It was not a killing factory then, although slave labor was always contemplated for the maximum profit factor. Auschwitz was designed to process Silesian coal into tar additives necessary for Russian aviation fuel. It was a high tech German chemical factory built to balance out Harriman' s Russiarto-Germany export trade.

The Rockefeller-Harriman front company that financed Auschwitz was called Brown Brothers Harriman. It is still around today. Our President' s great granfather, Herbert Walker, founded the company, and appointed his impecunious son-in-law Prescott Bush to the boards of several holding companies, all of which became Nazi fronts. The Walkers and Bushes never really liked the Nazis, anymore than Harriman liked the communists. To the robber barons, they were just dogs on a leash. One day the dogs broke their chains, and Hitler and Stalin got loose. Fifty million people died as a result of a bad investment.

The Robber Barons saw it coming. Their lawyers, the Dulles brothers, had a contingency plan. They had established three banks, one in Germany, one in Holland, and one in New York (the Union Banking Corporation, headed by the ever-useful son-in-law Prescott Bush). No matter who won World war II, the corporate stocks would be shifted around to whichever bank was in a neutral country when the war was over.

After WW II, the Dulles brothers' shell game deceived a gullible and warweary world. The "neutral" Dutch bank reclaimed their German assets as "stolen" by the Nazis, and the whole merry fraud continued. Prescott Bush got his Union Bank back from the US Government in 1951, despite its seizure in 1942 as a Nazi front. Prescott Bush and father-in-law Walker were paid two shares worth about \$1.5 million in 1951 dollars. It was a petty payoff for a job well done.

Nearly 4,000 shares (98% of the Union Bank holdings) were held by Roland Harriman in trust for the Rockefellers. That' s about three billion in 1951 dollars, more than 30 billion dollars in todays money. Most of it was reinvested in post-war Germany where they made even more obscene profits. After all, Germany was just as cash starved after World War II as they were after World War I. It was just another cycle in the Robber Baron' s spreadsheet. Everyone made money off the Holocaust, except of course the Jews and the Allied soldiers.

A few decades later things had quited down and all the Nazi money finally came home to Wall Street. By 1972, one of Rockfeller' s assets, the Chase Manhattan bank in New York secretly owned 38% of the Thyssen company, according to internal Thyssen records in my custody. Not a bad payoff for the Robber Barons. The Auschwitz investment paid off handsomely. The Thyssen-Krupp corporation is now the wealthiest conglomerate in Europe. WWII is over. The Germans won.

Also in the 1970' s, Brown Brothers Harriman, perhaps coincidentally, convinced the ever pliant New York State Banking Commision to issue a regulation permitting them to shred

all their records for the Nazi period. The Robber Barons, unlike the Swiss bankers, knew how to cover their tracks.

There were, of course, exceptions. Von Kouewenhoven, director of the Dutch Bank, discovered the secret Thyssen-Nazi connection after the war, and foolishly went to New York to warn his old friend Prescott Bush. His body was found two weeks later. It was reported with a straight face that he died of a heart attack.

A dear friend of mine, former American secret agent William E. Gowen, played a principal role in unravelling the entire Bush-Nazi scandal. Gowen confirmed that years after Von Kouenhowen' s death, another Dutch investigator, a journalist named Eddie Roeever, also suffered a convenient heart attack just as he was about to confront Baron Heinrich von Thyssen-BjornaMissa at his palatial London home, across from Margaret Thatchers.

Margaret Thatcher may not have known (or maybe she did) that her neighbor Baron Heinrich' s brother was the infamous Nazi, Fritz Thyssen, who served Brown Brothers Harriman at the heart of the Nazi war machine. The Dulles Brothers hired ghostwriters for Fritz' s mea culpa book "I Financed Hitler." To this day, gullible American media believe that Fritz Thyssen turned against Hitler in disgust at the last moment before WWII. Now that is spin!

The truth is that Prescott' s Unon Bank loaned the money to the Dutch Bank that loaned Hitler the money to build his first Nazi headquarters, the Braun Haus in Munich. The Thyssen' s factories built the Bismark, the rail lines to Auschwitz and Treblinka, and sent the rest of their steel to their cartel partners, Flick and Krupp. Together, these war criminals made the bullets and the bombs that killed our parents' generation. They got away with it.

It is not suprising that their grandchildren are ashamed of how their families made their money. The only suprise is that the American media is still afraid to go to the US national archives and look at the files that John Buchanan found. But then, I am not surprised at all.

Here is what I wrote nearly ten years ago in "The Secret War Against the Jews":

THE BUSH-DULLES-NAZI CONNECTION

"George Bush' s problems were inherited from his namesake and maternal grandfather, George Herbert ' Bert' Walker, a native of St. Louis, who founded the banking and investment firm of G. H. Walker and Company in 1900. Later the company shifted from St. Louis to the prestigious address of 1 Wall Street. . . .

"Walker was one of Hitler' s most powerful financial supporters in the United States. The relationship went all the way back to 1924, when Fritz Thyssen, the German industrialist, was financing Hitler' s infant Nazi party. As mentioned in earlier chapters, there were American contributors as well.

"Some Americans were just bigots and made their connections to Germany through Allen Dulles' s firm of Sullivan and Cromwell because they supported Fascism. The Dulles brothers, who were in it for profit more than ideology, arranged American investments in Nazi Germany in the 1930s to ensure that their clients did well out of the German economic recovery. . . .

"Sullivan & Cromwell was not the only firm engaged in funding Germany. According to ' The Splendid Blond Beast,' Christopher Simpson' s seminal history of the politics of genocide and profit, Brown Brothers, Harriman was another bank that specialized in investments in Germany. The key figure was Averill Harriman, a dominating figure in the American establishment. . . .

"The firm originally was known as W. A. Harriman & Company. The link between Harriman & Company' s American investors and Thyssen started in the 1920s, through the Union Banking Corporation, which began trading in 1924. In just one three-year period, the Harriman firm sold more than \$50 million of German bonds to American investors.

' Bert' Walker was Union Banking' s president, and the firm was located in the offices of Averill Harriman' s company at 39 Broadway in New York.

"In 1926 Bert Walker did a favor for his new son-in-law, Prescott Bush. It was the sort of favor families do to help their children make a start in life, but Prescott came to regret it bitterly. Walker made Prescott vice president of W. A. Harriman. The problem was that Walker' s specialty was companies that traded with Germany. As Thyssen and the other German industrialists consolidated Hitler' s political power in the 1930s, an American financial connection was needed. According to our sources, Union Banking became an out-and-out Nazi money-laundering machine. . . .

"In [1931], Harriman & Company merged with a British-American investment company to become Brown Brothers, Harriman. Prescott Bush became one of the senior partners of the new company, which relocated to 59 Broadway, while Union Banking remained at 39 Broadway. But in 1934 Walker arranged to put his son-in-law on the board of directors of Union Banking.

"Walker also set up a deal to take over the North American operations of the Hamburg-Amerika Line, a cover for I.G. Farben' s Nazi espionage unit in the United States. The shipping line smuggled in German agents, propaganda, and money for bribing American politicians to see things Hitler' s way. The holding company was Walker' s American Shipping & Commerce, which shared the offices at 39 Broadway with Union Banking. In an elaborate corporate paper trail, Harriman' s stock in American Shipping & Commerce was controlled by yet another holding company, the Harriman Fifteen Corporation, run out of Walker' s office. The directors of this company were Averill Harriman, Bert Walker, and Prescott Bush. . . .

". . . In a November 1935 article in Common Sense, retired marine general Smedley D. Butler blamed Brown Brothers, Harriman for having the U.S. marines act like ' racketeers' and ' gangsters' in order to exploit financially the peasants of Nicaragua. . . .

". . . A 1934 congressional investigation alleged that Walker' s ' Hamburg Amerika Line subsidized a wide range of pro-Nazi propaganda efforts both in Germany and the United States.' Walker did not know it, but one of his American employees, Dan Harkins, had blown the whistle on the spy apparatus to Congress. Harkins, one of our best sources, became Roosevelt' s first double agent . . . [and] kept up the pretense of being an ardent Nazi sympathizer, while reporting to Naval Intelligence on the shipping company' s deals with Nazi intelligence.

"Instead of divesting the Nazi money," continue the authors, "Bush hired a lawyer to hide the assets. The lawyer he hired had considerable expertise in such underhanded schemes. It was Allen Dulles. According to Dulles' s client list at Sullivan & Cromwell, his first relationship with Brown Brothers, Harriman was on June 18, 1936. In January 1937 Dulles listed his work for the firm as ' Disposal of Stan [Standard Oil] Investing stock.'

"As discussed in Chapter 3, Standard Oil of New Jersey had completed a major stock transaction with Dulles' s Nazi client, I.G. Farben. By the end of January 1937 Dulles had merged all his cloaking activities into one client account: ' Brown Brothers Harriman Schroeder Rock.' Schroeder, of course, was the Nazi bank on whose board Dulles sat. The ' Rock' were the Rockefellers of Standard Oil, who were already coming under scrutiny for their Nazi deals. By May 1939 Dulles handled another problem for Brown Brothers, Harriman, their ' Securities Custodian Accounts.'

"If Dulles was trying to conceal how many Nazi holding companies Brown Brothers, Harriman was connected with, he did not do a very good job. Shortly after Pearl Harbor, word leaked from Washington that affiliates of Prescott Bush' s company were under investigation for aiding the Nazis in time of war. . . .

". . . The government investigation against Prescott Bush continued. Just before the storm broke, his son, George, abandoned his plans to enter Yale and enlisted in the U.S. Navy. It was, say our sources among the former intelligence officers, a valiant attempt by an eighteen-year-old boy to save the family' s honor.

"Young George was in flight school in October 1942, when the U.S. government charged his father with running Nazi front groups in the United States. Under the Trading with the Enemy Act, all the shares of the Union Banking Corporation were seized, including those held by Prescott Bush as being in effect held for enemy nationals. Union Banking, of course, was an affiliate of Brown Brothers, Harriman, and Bush handled the Harrimans' investments as well.

"Once the government had its hands on Bush' s books, the whole story of the intricate web of Nazi front corporations began to unravel. A few days later two of Union Banking' s subsidiaries -- the Holland American Trading Corporation and the Seamless Steel Equipment Corporation -- also were seized. Then the government went after the Harriman Fifteen Holding Company, which Bush shared with his father-in-law, Bert Walker, the Hamburg-Amerika Line, and the Silesian-American Corporation. The U.S. government found that huge sections of Prescott Bush' s empire had been operated on behalf of Nazi Germany and had greatly assisted the German war effort." (1)

EDWIN PAULEY

"Try as he did," continue the authors, "George Bush could not get away from Dulles' s crooked corporate network, which his grandfather and father had joined in the 1920s. Wherever he turned, George found that the influence of the Dulles brothers was already there. Even when he fled to Texas to become a successful businessman on his own, he ran into the pirates of Wall Street.

"One of Allen Dulles' s secret spies inside the Democratic party later became George Bush' s partner in the Mexican oil business. Edwin Pauley, a California oil man, was . . . one of Dulles' s covert agents in the Roosevelt and Truman administrations . . . a ' big business' Democrat. . . ."

Among the key posts held by Pauley were: treasurer of the Democratic National Committee, director of the Democratic convention in 1944 and, after Truman' s election, Truman appointed him the "Petroleum Coordinator of Lend-Lease Supplies for the Soviet Union and Britain."

Just after the end of World War II, "in April 1945 Truman appointed Pauley as the U.S. representative to the Allied Reparations Committee, with the rank of ambassador," as well as "industrial and commercial advisor to the Potsdam Conference, ' where his chief task was to renegotiate the reparations agreements formulated at Yalta.' As one historian noted, the ' oil industry has always watched reparations activities carefully.' There was a lot of money involved, and much of it belonged to the Dulles brothers' clients."

At the same time, report Loftus and Aarons,

"the Dulles brothers were still shifting Nazi assets out of Europe for their clients as well as for their own profit. They didn' t want the Soviets to get their hands on these assets or even know that they existed. Pauley played a significant role in solving this problem for the Dulles brothers. The major part of Nazi Germany' s industrial assets was located in the zones occupied by the West' s forces. As Washington' s man on the ground, Pauley managed to deceive the Soviets for long enough to allow Allen Dulles to spirit much of the remaining Nazi assets out to safety. . . ."

"Pauley, a key player in the plan to hide the Dulles brothers' Nazi assets, then moved into another post where he could help them further. After successfully keeping German assets in Fascist hands, Pauley was given the job of ' surveying Japan' s assets and determining the amount of its war debt.' Again, it was another job that was crucial to the Dulles clique' secret financial and intelligence operations." (2)

After Pauley retired from government work he went back to being an independent oil man. Loftus and Aarons state that: "In 1958 he founded Pauley Petroleum which: . . . teamed up with Howard Hughes to expand oil production in the Gulf of Mexico.

"Pauley Petroleum discovered a highly productive offshore petroleum reserve and in 1959 became involved in a dispute with the Mexican Government, which considered the

royalties from the wells to be too low.

"According to our sources in the intelligence community, the oil dispute was really a shakedown of the CIA by Mexican politicians. Hughes and Pauley were working for the CIA from time to time, while advancing their own financial interests in the lucrative Mexican oil fields. Pauley, say several of our sources, was the man who invented an intelligence money-laundering system in Mexico, which was later refined in the 1970s as part of Nixon' s Watergate scandal. At one point CIA agents used Pemex, the Mexican government' s oil monopoly, as a business cover at the same time Pemex was being used as a money laundry for Pauley' s campaign contributions. As we shall see, the Mexican CIA connection played an important part in the development of George Bush' s political and intelligence career. . . .

"Pauley, say the ' old spies,' was the man who brought all the threads of the Mexican connection together. He was Bush' s business associate, a front man for Dulles' s CIA [Allen Dulles was CIA director then], and originator of the use of Mexican oil fronts to create a slush fund for Richard Nixon' s various campaigns. . . .

"Although it is not widely known, Pauley, in fact, had been a committed, if ' secret,' Nixon supporter since 1960. It should be recalled that Nixon tried to conceal his Mexican slush fund during the Watergate affair by pressuring the CIA into a ' national security' cover. The CIA, to its credit, declined to participate. Unfortunately, others were so enmeshed in Pauley' s work for Nixon that they could never extricate themselves. According to a number of our intelligence sources, the deals Bush cut with Pauley in Mexico catapulted him into political life. In 1960 Bush became a protege of Richard Nixon, who was then running for president of the United States. . . .

"The most intriguing of Bush' s early connections was to Richard Nixon, who as vice president had supervised Allen Dulles' s covert planning for the Bay of Pigs [invasion]. For years it has been rumored that Dulles' s client, George Bush' s father, was one of the Republican leaders who recruited Nixon to run for Congress and later convinced Eisenhower to take him on as vice president. There is no doubt that the two families were close. George Bush described Nixon as his ' mentor.' Nixon was a Bush supporter in his very first tilt at politics, during his unsuccessful run for the Senate in 1964, and turned out again when he entered the House two years later.

"After Nixon' s landslide victory in 1972, he ordered a general house cleaning on the basis of loyalty. ' Eliminate everyone,' he told John Ehrlichman about reappointments, ' except George Bush. Bush will do anything for our cause.' . . . According to Bush' s account, the president told him that ' the place I really need you is over at the National Committee running things.' So, in 1972, Nixon appointed George Bush as head of the Republican National Committee.

"It was Bush who fulfilled Nixon' s promise to make the ' ethnic' emigres a permanent part of Republican politics. In 1972 Nixon' s State Department spokesman confirmed to his Australian counterpart that the ethnic groups were very useful to get out the vote in several key states. Bush' s tenure as head of the Republican National Committee exactly coincided with Laszlo Pasztor' s 1972 drive to transform the Heritage Groups Council into the party' s official ethnic arm. The groups Pasztor chose as Bush' s campaign allies were the emigre Fascists whom Dulles had brought to the United States. . . .

". . . Nearly twenty years later, and after expose' s in several respectable newspapers, Bush continued to recruit most of the same ethnic Fascists, including Pasztor, for his own 1988 ethnic outreach program when he first ran for president.

"According to our sources in the intelligence community," state the authors, "it was Bush who told Nixon that the Watergate investigations might start uncovering the Fascist skeletons in the Republican party' s closet. Bush himself acknowledges that he wrote Nixon a letter asking him to step down. The day after Bush did so, Nixon resigned.

"Bush had hoped to become Gerald Ford' s vice president upon Nixon' s resignation, but he was appointed U.S. ambassador to the UN. Nelson Rockefeller became vice president and chief damage controller. He formed a special commission in an attempt to preempt the Senate' s investigation of the intelligence community. The Rockefeller Commission into

CIA abuses was filled with old OPC [Dulles' s Office of Policy Coordination] hands like Ronald Reagan, who had been the front man back in the 1950s for the money-laundering organization, the Crusade for Freedom, which was part of Dulles' s Fascist ' freedom fighters' program." (3)

In 1988, Project Censored, a news media censorship research organization, awarded the honor of "Top Censored story" to the subject of George Bush. The article revealed "how the major mass media ignored, overlooked or undercovered at least ten critical stories reported in America' s alternative press that raised serious questions about the Republican candidate, George Bush, dating from his reported role as a CIA ' asset' in 1963 to his Presidential campaign' s connection with a network of antSemitites with Nazi and fascist affiliations in 1988." Is George H.W. Bush Really Prescott Bush's Son? Or Is He The Son Of Inventor Nikola Tesla's German-Born Accountant, George H. Scherff, Sr.?

Eric Orion in his yet to be published book, *The Bush Connection*, claims SS Nazi, Otto Skorzeny, told him in a death bed confession that Bush has been lying all along about his identity and was born in Germany, the son of Tesla's accountant.

The history books say Hitler's personal body guard and henchman Otto Skorzeny died in 1975.

Eric Orion of Florida says the former Nazi killer was alive and well only a few years ago, living under a fake CIA alias as a south Florida carpenter.

According to Orion, Skorzeny died several years ago at the ripe old age of 95 but not before he spilled out his guts to him in a death bed confession.

And after hearing Skorzeny's story -- a story so bizarre and incredible -- it simply leaves mouths hanging wide open, wondering how in the world this could happen in America.

"I was dating this girl in south Florida and her father turned out to be the feared Nazi SS body guard to Hitler, Otto Skorzeny," said Orion in an extended conversation from his Florida home, adding Skorzeny spilled the beans himself, not his x-girlfriend who remains tight lipped about her father's past. "When I met him, he was 90 but looked a lot younger. He was 6'4" with the biggest hand I ever shook in my life."

Recently, Orion also was a guest on Greg Szymanski's radio show, *The Investigative Journal*, where he claimed, based on Skorzeny's allegations, the American government has been lying since 1945 about the identities and whereabouts of thousands of former Nazis given safe haven and living in America today.

Orion also said Skorzeny gave him "a shoebox full" of never before published pictures, linking many high-ranking American officials to Nazi war criminals, as well as information that George H. Bush has been lying about his true identity and was really the adopted son of Prescott Bush.

He also claims that Hitler was given safe haven in America and Nazi criminals, Dr. Josef Mengele, nicknamed the Angel of Death, and Nazi SS killer, Reinhard Gehlen, were still alive and walking the streets of America as of three years ago.

"I met with Skorzeny on three separate occasions for roughly five hours and he said that George H.W. Bush was and is a SS Nazi spy born in Germany as George H. Scherff, Jr.," said Orion. "He told me that Bush was really the son of Dr. Nikola Tesla's German born, illegal immigrant accountant, George H. Scherff, Sr., being later adopted by Prescott Bush.

"Apparently, according to Skorzeny, in 1938, Hitler sent 14-year-old George Jr. to befriend, spy and kill Tesla, who later on Jan. 6, 1943, was actually killed by Skorzeny and SS Nazi Reinhard Gehlen. Bush, however, later forged a birth certificate while Prescott Bush, a known Nazi, adopted him, covered his real identity and later helped him join

the Navy under false pretenses."

Asked if he thought Skorzeny had any reason to lie and why he was chosen to hear his deathbed confession, Orion added:

"No, I believe he is for real. His pictures matched up with the history books and he told me he was coming forward with this information because the Bush family had cheated him out of a lot of money over the years. In the end, I think he wanted to get even and there were so many specifics that later I verified, leading me to believe he was telling me the truth.

"I also spent five years researching this information and have written a book, called *The Bush Connection*, yet to be published. Like I said my book took five years of painstaking research to complete and my motivation was to show Americans how our government illegally brought over 50,000 Nazis to America to create a New World Order and Fourth Reich in America under the guidance of George H. Bush.

"I also want to say that I've learned throughout the course of my research that our government is still protecting these Nazis, like they did Skorzeny up until his death."

After learning about the damaging Bush information and the underground network to hide Nazis, Orion went to the Justice Department for help but instead received nothing but harassment and death threats.

"They came after me big time," he said. "Right after I told them I was at my girlfriend's house and her mother went white as a ghost after receiving a phone call. I think she was informed that I was on to her husband's identity.

"That night after I left Skorzeny's house, I was followed, run off the road and it looked like one of the men in the car had a handgun. They are also tracking my mail, as well as hacking into my computer and keeping a close eye on my activities."

Besides the Bush allegations, Skorzeny laid several other bombshells on Orion, including the truth about Adolph Hitler's death and that Bush's role as a war hero was intentionally fabricated.

"Skorzeny told me he helped fake Hitler's suicide in 1945 and actually shot Hitler's double between the eyes, leaving him there in place of Adolph," said Orion. "He then said that he flew off with Hitler and SS Nazi pilot Hanna Reitsch to safety in Austria. Skorzeny then told me he turned himself in to Americans and later helped co-found the American CIA with Nazi George H. Scherff, Jr., aka George H. Bush."

Orion also said that Skorzeny confirmed reports that already surfaced in the *New York Post* made by an old war buddy of Bush, Chester Mierzejewski, who questioned Bush's account of how his plane went down during World War II, leading to his so-called "hero status."

In the article, Mierzejewski, who was a recipient of The Distinguished Flying Cross, claimed he had a bird's eye view of the Bush cockpit when he saw Bush abandon his crew and bail out, leaving his two crew members to die.

Robert Flood, a former B-17 bombardier, also claimed Bush was "no war hero," saying he violated the primary rule for a captain of a multi-crew aircraft.

"The pilot never leaves the airplane with anybody in it," said Flood.

Orion said that Skorzeny told him the CIA is really Hitler's "Third Reich" in America, the agency being created to manipulate intelligence and lie to the American people.

Going back to the stolen Tesla technology and the CIA's role, he added:

"The CIA uses stolen Tesla technology, according to Skorzeny, to spy on Americans and manipulate the weather. There are thousands of satellites orbiting the earth that project high intensity positively charged laser beams to certain areas on the earth. These positively charged laser beams enable the New World Order Nazis/C.I.A. to use their stolen Tesla Technology to manipulate the weather & to transmit extremely low frequency "elf" waves with subliminal messages for mind control purposes.
